AMENDMENT TO
PROGRAM GRANT AGREEMENT
(the "Grant Agreement")

BETWEEN

THE GLOBAL FUND TO FIGHT AIDS, TUBERCULOSIS AND MALARIA
(the "Global Fund")

AND

UNITED NATIONS DEVELOPMENT PROGRAMME
(the "Principal Recipient")

WHEREAS,

1. the Global Fund entered into the Grant Agreement for Grant Number AGO-405-G03-H with the Principal Recipient on 27 June 2005 for the purpose of providing funds to implement a HIV/AIDS program in Angola described more fully in the Grant Agreement as "Reducing the burden of HIV/AIDS in Angola" (the "Program");
2. In accordance with Article 12 and 20 of the Standard Terms and Conditions of the Grant Agreement, the Grant Agreement was amended by Implementation Letters dated 6 March 2006, 12 October 2007, 21 February 2008, 10 June 2009, 29 November 2010, 8 August 2011 and a Phase 2 Amendment to the Program Grant Agreement date 6 February 2008, 1 June 2011 and 28 June 2011;
3. Article 3.d of the Standard Terms and Conditions of the Grant Agreement states that "[u]nless the Global Fund agrees otherwise in writing, the Global Fund will not authorize disbursement of the Grant after the 'Program Ending Date' (specified in block 5 of the face sheet of this Agreement)";
4. The Global Fund has approved additional funding for the Program through the Transitional Funding Mechanism for a specified set of activities and period of time. Accordingly, subject to certain conditions, the Global Fund wishes to: (i) continue disbursement of funds under the Grant; and (ii) extend the Program Ending Date;
5. The "Program Ending Date" specified in block 5 of the face sheet of the Grant Agreement is 30 September 2014;
6. Grant funds in the amount of \$20,621,938 were committed but not disbursed to the Principal Recipient by 30 September 2012;
7. The amount of \$5,419,968 has been de-committed from the Global Fund trustee account to reflect the Grant funds needed for the Transitional Funding Mechanism and such de-committed funds will no longer be available for use; and



8. The grant amount as set forth in Block 7 of the face sheet has been reduced from \$86,120,215 to \$ 80,700,247, accordingly.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein and intending to be legally bound, the parties hereby agree to amend the Grant Agreement as follows:

1. The existing face sheet of the Grant Agreement is replaced by the face sheet attached hereto.
2. The Standard Terms and Conditions of the Grant Agreement are replaced with those attached hereto.
3. Annex A of the Grant Agreement, (exclusive of any attachments that have formerly been attached to such Annex A) is replaced with the revised Annex A attached hereto entitled "Annex A: Program Implementation Abstract".
4. The document entitled "Performance Framework, TFM Period: Indicators, Targets and Periods Covered" attached hereto is attached to Annex A of the Grant Agreement, as revised by this Amendment.
5. The document entitled "Summary Budget, TFM Period" attached hereto is attached to Annex A of the Grant Agreement, as revised by this Amendment.

All other provisions of the Grant Agreement shall remain in full force and effect.
