Subject: Financial commitment letter

The Government of the Republic of Armenia confirms its full support to the implementation of the project "Elimination of Obsolete Pesticide (OP) Stockpiles and addressing Persistent Organic Pollutants (POPs) Contaminated Sites within a Sound Chemicals Management Framework in Armenia" financed by the Global Environmental Facility (GEF) and implemented by UNDP. The project aimes at removal and sound destruction of known POPs and obsolete pesticide stockpiles in Armenia. The elimination of a POPs pesticide burial site in Nubarashen representing the major POPs stockpile and waste legacy for the country will be delivered by this project.

The principal GEF benefit from the project will be the elimination of 1,050 t of OPs, including POPs pesticides. Overall, a total of 7,100 t of POPs waste as defined by the Stockholm Convention will be eliminated and an additional 12,700 t of relatively low concentration POPs wastes will be securely contained such that a low probability of any release and/or impact on health and environment will occur.

The project is fully in line with strategic priorities of the Government in waste management and clean production sectors, including its national obligations under the Stockholm Convention. The proposal has been extensively discussed with national stakeholders to approve its major strategic directions and project outcomes. The Government's committments (cash and in-kind contributions) to co-finance project activities from the state budget and the national Mid-term Expenditure Framework were similarly covered in the national consultations.

A recent, dated April 2014, institutional change in the Government initiated with the resignation of the former Prime-minister of the Republic of Armenia had resulted in subsequent restructuring of the Cabinet of Ministers, and redesigning of the Government's

financial and development program. This, in turn, led to delays in completing co-finance support consultations with key implementing partners of the project.

By issuing the current letter of support, hereby, I would like to use the opportunity to confirm the commitment of the Government of Armenia to mobilise state-budget resources as a principal source of co-finance, which along with secured commitments from other multilateral agencies and bilateral development cooperation agencies will ensure the timely implementation and completion of the project. To this end, the Government of Armenia will ensure the provision of 16,020,000 USD (cash and in kind) as cofunding to the project.
