The proposed project will build on the extensive past programming and lessons learned, and will focus on identified gaps in democratization, governance, gender equality and human rights sectors with a view to deepen democracy and participation, improve protection and respect for fundamental human rights during the transition period while also delivering tangible services for women and men, The results of the project will have an impact on fundamental human rights including children's and women's rights as well as promoting tolerance and non-violence.

**Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment**

The project will be implemented by a consortium of UN agencies, where gender dimension is covered mainly by UNFPA, through activities directed at women empowerment on community level. UNDP will be contributing to the ultimate goal of equal participation, access to affordable, inclusive and accountable services by implementing the following activities:

*1.1 Dedicated channels for collecting and analysing citizen feedback on public services at national and local level established.*

1.1.1. Design and deployment of feedback mechanisms for collecting and analysing citizen feedback on public services at municipal level.

1.1.2 Provide technical support to national government on collection and analyses of citizen feedback on digital public services.

*1.2 Civil Society/citizens oversight of public services at local level established*

1.2.1 Open grant competitions for CSOs and active groups for monitoring OGP Action Plan implementation.

1.2.2 Grant support for empowerment of trade unions and civic groups on labour rights.

*2.1. Youth and vulnerable groups are empowered and have the skills to engage more meaningfully in governance and development and policy-making at local and national level.*

2.1.1 Organize open challenges to collect citizen-driven innovative ideas in the regions of Armenia.

2.1.2 Co-design and incubation of selected citizen-driven innovations.

The mechanisms envisaged through these activities will include grant support (with equal gender disaggregation of grantees), as well as start-up support schemes, which give an entry level opportunity where young women participation has traditionally been dominant in UNDP record. The activities will also support creation of online feedback mechanisms, which diminish human interaction and give more chance to regional and rural women to voice their complaints and suggestions, taken the dominant patriarchal and conservative perceptions in the target regions.

Environmental sustainability is a core value embedded in the design of the project. As part of the project, UNDP has envisaged the following activity:

2.2. Number and quality of dedicated spaces of dialogue and consultation for local/national and sectorial development of plans, strategy policy discussions/laws and sub laws and community budgets.

2.2.1 Support to co-creation of community public spaces to mobilize youth around public challenges in the regions of Armenia

The activity assumes placemaking as a mechanism to increase community social cohesion. Physical reconstruction and urban design are planned as part of the activity. UNDP will monitor closely possible environmental impact of the construction and will consult with UNDP relevant teams and the community at large.
