Women Economic Empowerment is a women empowerment project in its core. The project objectives contribute to Outcome 1 of UNDAF 2016-2020: "By 2020, Armenia's competitiveness is improved and people, especially vulnerable groups, have greater access to sustainable economic opportunities; and to the UNDP Country Program Outcome 3. 3.1.2. Number of women benefitting from private/public measures to support women's preparedness for leadership and decision-making roles. The project also responds to SDG 5: Achieve gender equality and empower all women and girls; 5.5: Ensure women's full and effective participation and equal opportunities for leadership at all levels of decision-making in political, economic and public life.

From the point of view of legal environment, societal norms and standards, issues gender equality and women participation contain sensitivity elements especially for those groups of the population which display conservative attitude.
