The project is a standalone women economic empowerment initiative and focuses on promotion of vulnerable women's access to employment and/or self-employment as well as to labor market. Overall, capacity development activities, knowledge products, policy recommendations will be developed based on the human rights principles and with highlight of those.
<i>Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment</i>

Women Economic Empowerment is a women empowerment project in its core. The project objectives contribute to Outcome 1 of UNDAF 2016-2020: “By 2020, Armenia’s competitiveness is improved and people, especially vulnerable groups, have greater access to sustainable economic opportunities; and to the UNDP Country Program Outcome 3. 3.1.2. Number of women benefitting from private/public measures to support women’s preparedness for leadership and decision-making roles. The project also responds to SDG 5: Achieve gender equality and empower all women and girls; 5.5: Ensure women’s full and effective participation and equal opportunities for leadership at all levels of decision-making in political, economic and public life.

From the point of view of legal environment, societal norms and standards, issues gender equality and women participation contain sensitivity elements especially for those groups of the population which display conservative attitude. The project will ensure that that overarching intervention strategy both at national and local level is conflict sensitive and is based on a solid understanding of the context/ actors and is implemented in regular consultations with partners (other donors, national counterparts, CSOs, etc.) This will allow to ensure that the planned activities support connections between various groups of population and groups and strengthen social cohesion.

The project includes a number of positive actions for social inclusion aimed to tackle the effects of inequality, change attitudes and behavioral patterns and enable women and youth groups at community level to fully participate in governance. We specifically aim to encourage community members, local and national authorities to promote a sense of belonging, empower people to play a part in improving their economic condition/stability and increase wage earning .

The project will employ small grant schemes for women-led initiatives covering various aspects of economic development. In cases when the local initiative has an environmental dimension, the project will ensure that the proper expertise reaches the project implementers both from UNDP and the external parties, and the project contributes to the sustainable community development, even if in small scale.
