**IMDA Amendment n° 2 - Amendment by mutual consent of Indirect
Management Delegation Agreement**

Dear Ms HENRIKSON,

We are pleased to inform you that we hereby agree to your above-mentioned modification request regarding the element(s) of the Action specified therein.

Articles 2(2), 2(3), 3(1) and 3(2) are replaced by the following Articles:

- 2.2 The implementation period of the Action shall run for ~~12~~ **22 months** from **01/04/2018** ('the start date of the Action').
- 2.3 The eligibility period of the Action shall be from **01/03/2018 01/04/2018** until the end of the implementation period of the Action specified in Article 2.2.
- 3.1 The total cost of the Action is estimated at ~~EUR 4 000 000~~ **EUR 5 000 000.00**.
- 3.2 The European Union undertakes to finance up to a maximum of ~~EUR 4 000 000~~ **EUR 5 000 000.00**.

We remind you that in accordance with Art. 4.1 of the above agreement, your Organisation shall submit an Interim Report on the Action's implementation three months before the end of the implementation period of the Action, covering the implementation up to one month before the reporting date.

The amendment to the Agreement shall take effect as of the date indicated in Article 2(3) of the Agreement.

The request and this letter constitute an amendment and are an integral part of the Agreement.
