I'd appreciate to provide clarifications on the below situations:

- 2 Projects (outputs) #s 10012 and 112162, highlighted in blue in the attachment, do not have award (project) number in Atlas – [redacted]

**Thank you. This is noted.**

- 2 awards (projects) operationally closed, highlighted in orange in the attachment, that are still open. One of them was closed for more than 12 months. – [redacted]

**Noted. Please, update when transfer of the balance is done.**

- Award (project) 59750, including 3 outputs, with end date in December 2017 is still with 'active' status in Atlas. – [redacted]

**Noted. Please, update when projects are closed.**

- Award (project) 60062 with end date 30 June 2018, did not have activities since 2017 and still with "active" status in Atlas. What is the current status of the project? – [redacted]

**Can you please share the letter to the IP?**

- Award (project) 80256 with end date 31 Dec 2019, however it didn't have any activity in 2018. What is the current status of the project? – **Progress Report Attached**

**Noted. Can you please, share the project AWP for 2019?**

- Award (project) 66219 with end date in June 2019 but with no activities since 2017. Update on its status. **The intention is to finalize some pending activities related to gender empowerment and then close the project in 2019. At the same time, the agreement is a key building block between UNDP and UCB to explore the mutual intentions to pave the way for a new project that is currently being designed with the University team, and hopefully signed in the next month and a half or so. It will be on ethics and innovation, and how UNDP will support the University in that.**

**Can you please share the detail of the remaining balance of this project?**

- Award (project) 79015 'UNCT Workplan 2014&2015'. What will be the decision on this project after the delinking? **All requirements have been considered under HQ guidance with the exception of Assets. We consulted Asset Management Section in Kuala Lumpur on the transfer of Assets. They are waiting for further guidance from HQ on this. Once the assets are transferred, the project will be closed as ATLAS.**
