# 1) Key achievements:

*i.* What are the major achievements of your IBSA Fund project - over the reporting period – as planned on the Project document and AWP 2020?

Despite UNDP and FEGABENI's efforts, the 2020 drilling schedule for wells could not be restarted due to the strict lockdown measures in place in Bolivia since March 2020, along with a period of political and social unrest until the national elections were held on October 18, 2020. With a new government in office, project activities resumed gradually albeit at a slow pace.

The Project Steering Committee met on November 20, 2020 with the participation of the Embassy of Brazil in Bolivia, to approve the action plan to restart the drilling of wells with highly subsidized costs to benefit the most vulnerable people in urban and rural communities and contribute in the fight against COVID-19 by prioritizing drilling wells in areas where water for the population and health facilities are required urgently.

Following the Committee's decisions, a Non-Cost-Extension was requested to the IBSA Fund Board of Directors, along with a substantive project document revision on the subsidies scheme for wells completed within the project scope.

On December 23, 2020, the NCE extension was approved until August 31, 2021. A substantive revision to the project document will be sent shortly, with adjusted targets, timeline, and monitoring plan, duly signed by all the authorities who had signed on the original PRODOC.

#### 5) Achievements in strengthening South-South cooperation

The participation of the Embassy of Brazil in Bolivia in the Board of Directors meeting was important to learn from their experience with similar projects.

#### 6) Lessons Learned

The municipalities' commitment to allocate counterpart funds to cover the materials required for the drilling of 38 wells for rural and urban communities was not fulfilled, so the Project would use the remaining resources to cover the required materials and subsidize the cost for the most vulnerable communities/ beneficiaries. The lesson learned was that, a formal agreement must be signed with the municipalities and a follow up activities must be taken to ensure that it is included in the budget.

## 7) Sustainability

To meet the project's objectives and make it sustainable, FEGABENI has established the goal of drilling at least two wells per month for each drilling rig for the next three years, which would lead to closely meet the originally established project target. Overall, this would result in a total of 20 wells dug by the project at a fully subsidized rate for the most vulnerable and indigenous communities within August 2021, and around 75 wells dug by the project partner FEGABENI, in parallel or thereafter, at a partly subsidized rate of around 55% of market prices.
