# AGREEMENT FOR THE PROVISION OF SERVICES BETWEEN THE UNITED NATIONS DEVELOPMENT PROGRAMME IN BRAZIL/ INTERNATIONAL POLICY CENTRE FOR INCLUSIVE GROWTH AND THE UNITED NATIONS DEVELOPMENT PROGRAMME'S REGIONAL SERVICE CENTRE FOR AFRICA IN ADDIS ABABA ETHIOPIA

The United Nations Development Programme in Brazil/International Policy Centre for Inclusive Growth (hereinafter referred to as "UNDP Brazil") and the UNITED NATIONS DEVELOPMENT PROGRAMME'S REGIONAL SERVICE CENTRE FOR AFRICA (hereinafter referred to as "UNDP RSCA") hereby agree that the UNDP Brazil will provide the design and implementation of a social protection leadership and transformation training (TRANSFORM) to African institutions engaged in the field of social protection.

# I. Objective:

The objective of the project is to review the TRANSFORM curriculum, adapting it to a blended format (online and face-to-face training materials and activities) and to set up a learning environment to host the virtual component based on the adapted materials of the TRANSFORM blended course.

# II. Main Outputs, Activities and Deliverables

Output 1 – To review the TRANSFORM curriculum, adapting it to a blended format (including online and face-to-face training materials and activities).

## **Activities:**

- I. Review the content of lectures and activities of the existing e-TRANSFORM curriculum and other available TRANSFORM training materials and propose revised design and content of materials for the blended format (change of flow, instructions etc.).
- II. Based on the results of the review, adapt existing standard (face-to-face and online) training materials (including slides, videos, and handouts) in line with the revised flow and content of the blended format.
- III. Conduct a pedagogical and methodological analysis, ensuring that both components (online and face-to-face) complement each other.

IV. Develop an e-facilitators guide, with the methodology and the formulation of learning objectives, activities description, content sequencing, and the definition of instructional, delivery and evaluation strategies

**Deliverable 1:** Blended version of the TRANSFORM Curriculum – including both the online and face-to-face components – submitted to UNDP Regional Centre for Africa by February 2022.

Output 2 – To set up a learning environment to host the virtual component based on the adapted materials of the TRANSFORM blended course.

## **Activities:**

- I. Adaptation of the courseware, which means the integration of the virtual content elements into socialprotection.org's learning platform.
- II. Revision of the courseware, ensuring all elements are properly functioning and integrated.

**Deliverable 2:** Learning environment hosting the online component of the TRANSFORM blended course materials and activities, to be delivered to UNDP Africa by March 2022.
