#### Approval of funding tranches for Barbados's HCFC Phase-out Management Plan, Stage-I

We are pleased to inform you that the following project components were approved for UNDP implementation, as part of the HCFC Phase-out Management Plan (HPMP) Stage-I, for Barbados, at the 69<sup>th</sup> Meeting of the Montreal Protocol MLF Executive Committee held in April 2013.

**Background:** This funding is approved in-principle by the MLF Executive Committee, to assist Barbados in complying with the 2013 and 2015 control measures for HCFCs under the Montreal Protocol and is subject to the provisions of the performance-based agreement between the MLF Executive Committee and Barbados (attached as Annex-II), comprising of annual/biennial HCFC consumption and phase-out targets. Approval of future funding tranches is contingent upon achievement of these targets, failing which Peru could be liable for penalty for non-compliance. Considering the performance-based agreements involving the beneficiary enterprises and/or the Government.

**Implementation Modality:** We are suggesting that this project be implemented through the National Implementation Modality (NIM).

**Project Document Format:** We are attaching herewith Barbados's HPMP Stage-I document as approved by the MLF Executive Committee (Annex-III). It is important to annex these documents, without any change, to the project document that will be signed between UNDP and the Government. No outputs, activities or inputs can be added or modified or deleted in the attached documents that were approved by the Executive Committee.

Once the project document has been signed please send the total approved budget, including future years to Commitment Control and send a copy of the signed cover page and request for ASL to MPU.
