It has been designed in accordance with the SDG Acceleration Fund criteria to Leave No One Behind, and as such focuses on supporting equity and equality of access to adaptive social protection of the most vulnerable groups to economic and climactic shocks. All of the work will be done in consultation/collaboration with UN Women as a key aspect of the strategy and methodology.

UNDPs activities in the joint programme will mainstream gender analysis to inform policy and programme development, and piloting of gender responsive interventions on community levels.
