Narrative

There is a critical need to include indigenous peoples in governance processes in order to ensure they too benefit from national development outcomes in a participatory and equitable manner. The Regional Indigenous Peoples' Programme will assist countries to deliver democratic, responsive and accountable governance mechanisms that takes into account the needs and priorities of its indigenous population by supporting regional dialogue and cooperation on indigenous peoples' issues; developing regional public goods on critical issues and emerging trends; facilitating knowledge sharing and learning; and strengthening the human and institutional capacity of key partners for more equitable and participatory governance. UNDP's Policy of Engagement with Indigenous Peoples (2001) and the UN Declaration on the Rights of Indigenous Peoples (2007) will provide the guiding principles, with gender, capacity development and south-south cooperation as key drivers for programming and policy support.


