ADMINISTRATION AGREEMENT

1. Pursuant to the Agreement regarding the UNDP/Sida Trust Fund for Assistance to UNDP concluded between the Government of Sweden ("Sida") and the United Nations Development Programme ("UNDP") on the first of September 2000, (the "Trust Fund Agreement"), I am pleased to inform you of the intention of Sida to make available a contribution (the "Contribution") of Four million Swedish kronor (SEK 4 000 000) to be administered by UNDP for ROC-05/P/HR/RL02 (Trust Fund No...000.4.3.637....., Sida Dnr 2005-128, Component 74002751). The terms of the Trust Fund Agreement shall apply to the Contribution. UNDP shall administer the Contribution in accordance with the provisions of the Trust Fund Agreement, except as otherwise provided herein.
2. The objectives of the project are Youth at risk reintegration project.
3. Out of the contribution, 8 per cent may be used as support costs in accordance with Article 7 (a), and 5 per cent as support costs in accordance with Article 7 (b) of the Trust Fund Agreement.
4. The funds are estimated to be utilized according to the following schedule:

5. The specific period during which the activities shall be undertaken is from 1 January 2005 to 31 December 2005. Only costs for activities carried out during this period may be financed from the Swedish Contribution. After six months from that latter date, the contribution shall not be available for disbursement. The Contribution shall be used exclusively for the purposes of the project for which they are intended and in accordance with the project document named Consolidated Appeals Process Republic of Congo 2005.
6. UNDP shall provide Sida with reports and information as provided in the Trust Fund Agreement. In addition hereto UNDP shall provide Sida with annual expenditure reports.

8. Sida and UNDP shall meet to plan and review the progress of ongoing activities of the project.
9. This Administration Agreement shall enter into force 1 January 2005 and remain valid until 30 June 2006 unless terminated earlier by either of the Parties giving three months' written notice to the other.
10. I would like to propose that this letter shall, upon your confirmation and agreement below, constitute an agreement between Sida and UNDP.
