

**Addendum No. 2 to the
Standard Administrative Arrangement
between
the Grand Duchy of Luxembourg,
the United Nations Resident Coordinator and
the United Nations Development Programme
regarding the contribution of Luxembourg to the Cape Verde Transition Fund**

The Grand Duchy of Luxembourg (hereafter referred to as the “Donor”), the United Nations Resident Coordinator (hereinafter referred to as the “Resident Coordinator”) and the United Nations Development Programme (hereinafter referred to as “UNDP”) acting as Administrative Agent of the Cape Verde Transition Fund on behalf of itself and all the Participating UN Organizations, (hereinafter referred to as the “Administrative Agent”) have agreed as follows:

WHEREAS, the Participating UN Organizations have agreed to extend the Cape Verde Transition Fund until **31 December 2017**.

Whereas in Article I, paragraph 1 of the Standard Administrative Arrangement signed between the Donor, the Resident Coordinator and the Administrative Agent (hereinafter referred to collectively as the “Participants”) on **26 January 2011**, the Donor committed itself to make a contribution of **Five Million Six Hundred and Sixty Seven Thousand Seven Hundred and Fifty Eight United States Dollars (USD 5,667,758)** “and such further amounts as it may decide”.

On 20 December 2013, the Donor committed itself to make a contribution of Two Million US Dollars (USD 2,000,000), earmarked to the Budget of the Joint Programme “Programme d’appui à la stratégie nationale de création d’emploi au Cap Vert”.

The Donor has now agreed to make a further contribution to the Cape Verde Transition Fund.

The Standard Administrative Arrangement between the Participants is therefore modified as follows:

Article 1 paragraph 1: The Donor agrees to make an additional contribution of up to **Five Million One Hundred and Thirty-Four Thousand Four Hundred and Twenty-Three Euros (5.134.423 EUR)**.

- Two Million Euros (2.000.000 EUR) for the Programme “*Plateforme pour le Développement Local et Objectif 20/30 au Cabo Verde*”
- Three Million One Hundred and Thirty-Four Thousand Four Hundred and Twenty-Three Euros (3.134.423 EUR) for the ILO - UNDP Programme d’appui à l’emploi, l’employabilité et l’insertion

Section 1, Paragraph 2: UNDP will proceed, in due time, to reimburse the Donor the totality of the unused contribution from the Standard Administrative Arrangement to the Joint Programme “*Soutien à la Sécurité Alimentaire et à la Nutrition Scolaire* “. The unspent balance will be deposited by wire transfer to the following account:
