III- UNDP BRAZIL/IPC-IG OBLIGATIONS

UNDP Brazil/IPC-IG is to perform the following tasks:

- (1) Outline of the Study in close collaboration with the UN Joint Office in Cape Verde;
- (2) Collection of information: literature review, data analysis, review of documents, organization of focus groups discussions, personal interviews;
- (3) Presentation of preliminary results;
- (4) Delivery of the first complete draft of the assessment to be shared and discussed with national partners;
- (5) Revision of the assessment and recommendations in response to comments and suggestions and the delivery of the final version of the assessment
- (6) Delivery of a 30 page report, executive summary, appendices with charts, tables, and a thorough description of the information collected. The economics adviser with the UN Joint Office in Cape Verde will be supervising the assessment

IV- UNDP CAPE VERDE OBLIGATIONS

UNDP CAPE VERDE is to perform the following activities:

- a) Provide the financial resource allowing the flow of the activities as planned in this agreement;
- b) Provide the logistic support for the field work of the IPC team: i. scheduling the necessary meetings with institutions, groups and individuals and ii. facilitate access to the available primary data;
- c) Provide support for interaction between IPC team and national stakeholders;
- d) Monitor the implementation of this Agreement.

V- DURATION

This agreement shall be valid until 31 March 2014.
