Progress to target during the period:

The document was developed which was revised by the colleagues from the Climate Change Office since 2018.

<u>Indicator 1.3</u>: A document with accounting rules for the AFOLU sector <u>Progress to target during the period</u>:

Indicator 1.4: A document with a set of uniformed indicators

Progress to target during the period:

A set of indicators has been identified, and methodologic sheets and data management process have been developed.

<u>Indicator 1.5</u>: A design document for the digital platform to strengthen Costa Rica's Transparency Framework in the AFOLU sector

Progress to target during the period:

The document for the digital platform has been developed, as well the digital solution was completed on March 2019.

<u>Indicator 1.6</u>: Inter-institutional agreement to reduce emissions from the agricultural sector signed <u>Progress to target during the period:</u>

The agreement was signed on February 2018 by the Minister of Environment and Energy, and the Minister of Agriculture and Livestock.

# <u>Indicator 2. 1:</u> Implementation Plan for the NDCs regarding the Energy sector consulted and approved by the Government

#### Progress to target during the period

The support provided was the revision, generation of inputs and support in the integration of comments to the National Plan for Electric of Transport review process. <u>Indicator 2.2:</u> Number of documents, strategies, policies and other relevant instruments prepared to support decision making in the framework of the energy sector reviewed.

#### Progress to target during the period

The following Executive Decrees where develop: 1-Intersectoral plan for the application of mechanisms to support vulnerable social groups from the Electricity Sector, 2- Intersectoral plan for the conservation and improvement of employment in electro-intensive companies. Also, the project has supported the regulation of electric vehicle incentives. All this where finalized in 2018.

## <u>Indicator 2.3:</u> Inter-institutional agreement to reduce emissions from the energy sector signed <u>Progress to target during the period</u>

In this case the Climate Change Office was requested by the Presidency to develop the National Decarbonization Plan, the office requested the support from the NDC-SP to elaborate the plan. This plan is Costa Rica's long-term strategy to 2050, the plan summarizes the strategic actions that the Government has identified to implement the decarbonization of the economy, where decarbonization and resilience are recognized as the means to transform the current economic development model into one that is based on bio-economy, green growth, inclusion, and on enhancing the well-being of all citizens.

# Product 3: Establish a roadmap and initiate a first pilot of the Climate Public Expenditure and Institutional Review (CPEIR)) exercise for Costa Rica

#### Indicator 3.1: Elaboration of the CPEIR roadmap

Progress to target during the period

The CPEIR roadmap will start in January 2019, the person to realize this consultancy will start the work in this month.

The CPEIR was develop in Costa Rica with a different approach since the country selected to elaborate a better diagnosis on how the government is investing on climate change related projects.

Another process develop was an analysis of tax exemptions applied by the Ministry of Finance to different economic activities, and to view which can promote the carbonization of the country's economy.

<u>Indicator 3.2:</u> Number of specialized exchanges with other countries that have made CPEIR <u>Progress to target during the period</u>

An exchange of views was made during the Climate Week LAC in 2018, the workshop had participation of colleagues from different Latin American countries, this workshop was denominated: "Technical dialogues on the monitoring of expenditure and financial flows for the implementation of NDC in Latin American countries".

Since the project is entirely related to the NDC implementation it is guided under the Climate Change Office of Costa Rica, which is the department in charge of the NDC. Therefore, close coordination with other partners as World Bank, GIZ, UN Environment (members of the NDC Partnership) on 2019 specifically on the climate finance related issues, as well on the development of the National Decarbonization Plan.

The engagement achieved on this regard, will continue 2020, since Costa Rica's NDC enhancement will be develop on the first half of the year.
