Jason might recall better the situation.

To my recollection and on reviewing, while there were many negative findings in the spot check, there was not a specific recommendation on the risk rating. The last PIRs indicated substantial implementation risk, primarily due to slowness rather than financial management.

But from the spot check we changed the IP, the PC and the Project Director which essentially dealt with the risks that arose. Therefore I don't recall and I'm not finding any documentation where we recommended full NIM and no advances. SSE received an advance last year.

Further to the portfolio review last Friday, I'd like to confirm the next steps regarding the above. With spot checks being due for all 4 projects, we'd said that since these are overdue since 2019, we can schedule them together for greater cost efficiencies. With Q3 being around the corner, is it therefore reasonable to plan these for the start of Sept, given that some audits are still not finished and hopefully there will be a level of normalcy by then? This would mean procurement mid-July to beginning of Aug latest. We would also need a HACT micro-assessment for Min of Climate Resilience in Grenada. Are those sufficiently related and/or would be done by the same company that we combine it with the spot check? **Cherryanne**, I'm relying heavily on your guidance for this.
