<p>The “Harnessing digital opportunities for a renewed image of Guinea-Bissau” project operates under the umbrella of the human rights-based approach (HRBA), gender equality, accountability and sustainability in all its programming. As part of its commitment to tap into digital opportunities to build institutional, operational and human capacity of the Ministry of Foreign Affairs and advance the implementation of SDG 16 and SDG 17, the project will aim to improve the functioning and performance of the Ministry of Foreign Affairs. This initiative not only is expected to contribute to improve government’s performance and capacity to function and deliver services but will also serve as a test ground to encourage a social and cultural shift, under the human rights principles of participation, inclusion, equality and non-discrimination, which is required to bring Guinea-Bissau at speed with the digital age. The project will ultimately intend to support the Government in its strategic communication and engagement in international fora to advance the Agenda 2030 for Sustainable Development. In its efforts, the project will promote the systematization and exchange of key information that can become lessons learnt to shape the CO response to E-Governance. By tapping into knowledge and insights at various level of interventions, the project aims at complementing UNDP’s interventions and tools on institutional building and E-Governance, an agenda which inherently linked to human rights.</p>

<p>Gender equality is mainstreamed in the project’s interventions. While the project does not directly aim at addressing the root causes of gender inequality or social norms that tend to exclude or marginalize women and vulnerable groups, it will seek to ensure the promotion and use of a gender sensitive communication. All contents to be developed in the online portal will adopt a gender sensitize language. The trainings to be provided to the personnel of the Ministry will also ensure gender mainstreaming in order to advance the gender equality agenda. international fora, the project will also consider how to ensure a better participation of the government in GEWE related initiative to better ensure its commitment to all relevant international agreements and standards with regards to GEWE.


