Brief Description of the Project

The SIDS and Post 2015 Agenda (SaPA) initiative seeks to support Caribbean Small Island and Developing States to effectively participate in and contribute to the successful outcome of the Third International Conference on SIDS, and to support the sub-regional efforts to advance the post Samoa agreement – SAMOA Pathway. The key results being pursued are: (i) The priorities of Caribbean SIDS are comprehensively presented in the Samoa Conference, (ii) Caribbean SIDS are present and visible during the Samoa Conference, (iii) Caribbean SIDS have facilitated and brokered knowledge among SIDS on issues of Climate Change, Disaster Risk Reduction and (iv) Caribbean SIDS have post Samoa action plans to continue advocating for special attention to SIDS in the process to develop a post 2015 development agenda.

General comments on the execution for 2014:

In 2014, UNDP and in particular its Regional Bureau for Latin America and the Caribbean (RBLAC) provided strategic technical, and financial support to enable the Caribbean sub-region to use the Third International Conference on Small Island Developing States as a significant opportunity to position the needs of the Caribbean in the global development debate and draw attention to the specific development circumstances of the region at critical juncture when the international community was defining the new global post 2015 development agenda to succeed the Millennium Development Goals (MDGs).

UNDP deployed its human, financial and other resources to buttress the efforts of Caribbean Governments, Civil Society Organisations (especially youth, women and indigenous peoples), and regional institutions such as CARICOM and the Organisation of the Eastern Caribbean States (OECS) to adequately prepare for and participate in the Samoa Conference. The support provided by UNDP under this project builds on previous support to the official SIDS preparatory process, where UNDP supported intra and inter-regional SIDS consultations, held in Jamaica and Barbados, respectively.

As a result of UNDP- RBLAC support, there was a high level of Caribbean participation in the Third Samoa which translated into stronger representation of Caribbean perspectives in the official deliberations during and decision of the conference, as reflected in the SAMOA Pathway¹.

UNDP Country Offices in the Caribbean played and the Regional Service Center in Panama played an extremely important political and logistical role in engaging and support Caribbean Governments, Regional Organisations and Civil Society Organisations in preparing for and participating in the conference.

I) MAIN PROJECT ACHIEVEMENTS

- Strong Caribbean participation in the pre, during and Post Samoa Conference. High level representation from the Caribbean funded and technically supported by UNDP-RBLAC from Governments, CARICOM, OECS, Youth, Women and Indigenous Peoples.
- 2. The Financing for Development needs and the severe vulnerability of Caribbean SIDS positioned as critical issues that require significant global rethink and investment. RBLAC organized and supported two high level side events that brought specific attention to the financing for development needs of Caribbean SIDS in the post 2015 era and highlighted the stellar achievement of Caribbean in South-South cooperation in the area of Disaster Risk Management, but also demonstrated the extreme vulnerabilities of Caribbean SIDS to climate related natural disasters.
- 3. Achieved consensus among Caribbean Governments on the key issues and positions for Caribbean SIDS leading up to the Samoa Conference.
- 4. Reinforced the capacity of CARICOM and OECS Secretariats to advocate for Caribbean SIDS by facilitating the participation of relevant high level participants.
- 5. High quality technical advice from a Caribbean perspective was provided. UNDP contributed a senior Caribbean national to assist with the preparatory activities in Samoa to ensure that Caribbean perspective is taken into account in all aspects of conference plans.

V) LESSONS LEARNT (Briefly describe the lessons learnt during the year.)

No.	Description	Application
1	UNDP had a very strong and effective presence in Samoa. Due to the support provided under this initiative, the Caribbean was able to position its financing for development challenges in a post 2015 era, while highlighting the region's exposure to exogenous shocks. This was only possible because of sustained partnerships forged internally and externally well in advance of the Samoa conference and the strong leadership UNDP brought to the Conference. As a key lesson therefore, it is therefore important that UNDP maintains and consolidates its partnership on SIDS issues with the support and visibility of senior leadership in the organisation.	A useful approach for positioning UNDP as a relevant global actor on specific issues that are close to the organisation's interest and mandate.
2	There is much value to bringing closer alignment between the work of UNDP in the anglophone Caribbean with that of the rest of the sub-region (for example Cuba, Haiti and Dominican Republic). As a result of the joint messaging, UNDP was able to demonstrate the extent to which DRR remains a formidable economic, political, and social challenge for the entire Caribbean region.	Programming in the area of DRR in the Caribbean should adopt a more holistic regional view by identifying common resilience building challenges that affect the English, Spanish, Dutch and French speaking Caribbean instead of the fragmented approach currently employed. An opportunity for regional programming gin a South-South framework.
