**AMENDMENT TO THE AGREEMENT**

**BETWEEN**

**UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP)**

**AND**

**THE MOHAMMED BIN RASHID AL-MAKTOUM FOUNDATION (DONOR)**

Reference is made to the Cost Sharing Agreement (hereinafter "Agreement") signed in 2007 between the UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP), and the MOHAMMED BIN RASHID AL-MAKTOUM FOUNDATION (MBRF), with respect to the Project The Arab Knowledge Report , and as per Article X of the Agreement, any modification to this Agreement shall be made in writing between both parties and duly signed by the authorized representatives of the Donor and UNDP.

Therefore Parties hereby agree on the following;

**WHEREAS** the donor and UNDP now wish to amend the said Agreement in order to reflect a revised the payment schedule and amount;

**WHEREAS** such Amendment will result in a decrease of USD 4,997,877 (United States Dollars Four Million Nine Hundred Ninety Seven Thousand Eight Hundred Seventy Seven) making this amended Agreement total USD 9,570,758 (United States Dollars Nine Million Five Hundred Seventy Thousand Seven Hundred Fifty Eight);

**NOW THEREFORE**, the relevant Agreement provisions indicated below are hereby amended to read as follows:


**NEVERTHELESS**, all other terms and conditions of the Agreement, except as amended herein, shall remain unchanged and shall continue in full force and effect.



