Dear Mr. SONG,

The United Nations Development Program (UNDP) presents its compliments and submits for your approval a request for a no-cost extension of the project: "Durable solutions for internally displaced persons (IDPs) in the locality of Lahaie, Commune of Dame Marie, Department of Grand'Anse".

This extension is necessary due to the delays accumulated in the implementation of the project. Indeed, the socio-political situation of the country and increased insecurity due to open gang warfare, as well as the health situation with COVID-19, have considerably impacted the implementation of the project between 2020 and 2021. The assassination of the Haitian President in July followed by the 14 August earthquake and Tropical Storm Grace have only exacerbated the situation.

Therefore, UNDP hopes that this extension will last for two years, ending the project on December 31, 2023. Progress reports will also be submitted according to a new schedule as specified below:

AMENDMENT NO. 2 TO THE GRANT ARRAGEMENT BETWEEN THE KOREA INTERNATIONAL COOPERATION AGENCY AND

THE UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP) ON "SUSTAINABLE SOLUTIONS FOR INTERNALLY DISPLACED PERSONS IN THE LOCALITY OF LAHAIE, GRAND ANSE DEPARTMENT"

Reference is made to the contribution agreement signed on December 8th, 2017, between the United Nations Development Programme (UNDP and the Korea International Cooperation Agency (KOICA) and together with UNDP the "Parties", (hereinafter referred to as the "Parties").

WHEREAS the contribution agreement provides that any modification thereto shall require an amendment in writing between the Parties, duly signed by the authorized representatives of UNDP and KOICA.

The purpose of this Amendment is to allow a no-cost extension of the Project and to let UNDP conclude outstanding activities remaining to be accomplished under the current Grant Arrangement and to finalize the implementation of the project.

NOW THEREFORE, the Parties agree:

- 1. The relevant agreement provisions indicated below are hereby amended as follows:
- a. Arrangement Article 3 of the Paragraph 1, is hereby amended as follows:

"The duration of the Project will be from the date on which this Agreement is signed until the end of the Project on December 31st, 2023"

b. Paragraph 4 is amendment as follows:

A Final Financial Statement certified by an authorized official from UNDP's Division of Management Services (Finance Branch) showing the total budget spending of the Project Will be submitted to KOICA headquarters via Country Office no later than June 30th of the following year in which the project is operationally completed. Draft shall be submitted one month earlier prior to due date, May 31st, 2024.

- c. The reporting schedules are hereby amended to read as described in the attached files.
- 2. Except as expressly modified in the accordance with Paragraph 1, 4 and Annex A, all other terms of the contribution agreement shall remain unchanged and shall continue in full force and effect.

3. This Amendment will come into effect as of the date of the last signature by UNPD and KOICA
