AMENDMENT No 1 TO THE GRANT ARRANGEMENT BETWEEN THE KOREA INTERNATIONAL COOPERATION AGENCY AND

THE UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP) ON "SUSTAINABLE SOLUTIONS FOR INTERNALLY DISPLACED PERSONS IN THE LOCALITY OF LAHAIE, GRAND ANSE DEPARTMENT"

Reference is made to the contribution agreement signed on December 8th, 2017 between the United Nations Development Programme ("UNDP"), and the Korea International Cooperation Agency (KOICA), and together with UNDP, the "Parties", (hereinafter referred to as the "Parties").

 - a. Paragraph 1, article 3 of the contribution agreement is hereby amended in its entirety to read as follows:
 - The duration of the Project will be 48 months from December 8th, 2017 to December 31st, 2021.
 - The contribution and reporting schedules are hereby amended to read as described in the attached files (respectively Annex A and B):
- (2) Except as expressly modified herein in accordance with paragraph 1 and Annexes A and B, all other terms of the contribution agreement shall remain unchanged and shall continue in full force and effect.

- c) The final instalment of One Million Thirty-Three Thousand Five Hundred Seventy-Eight and Eighty-Two American Dollars (USD 1,033,578.82) within 3 weeks after receipt and approval of UNDP's second biannual update in June 30th, 2019 by KOICA (as per paragraph 4);
