**Project Title:** Developing Community-Based Adolescent Reproductive Health, Education, and HIV/AIDS Prevention Activities in India  
**Program Area:** Women & Population

**Brief Description:** This innovative project aims to reduce the reproductive health vulnerability of young women in six selected districts in India, through a coordinated district-level response providing reproductive health services and information, strengthening community networks and support systems and empowering young women with skills to improve their livelihoods. A multi-pronged strategy will be utilized to address: district-level information-gathering; awareness building; social mobilization; skills building; service delivery improvement; strengthening of support structures; district-level management and coordination mechanisms; and development of an enabling environment for social and policy change. This project brings the active participation and financial resources of the Dutch Government together with the UN Foundation to build a comprehensive adolescent reproductive health network in India.

fixed supplemental challenge grant for the project, *Developing Community-Based Adolescent Reproductive Health, Education, and HIV/AIDS Prevention Activities in India*, requested for funding in the amount of \$5,600,000.00.

RESOLVED, that a grant from the Corporation is hereby approved in principal in the amount of Two Million Eight Hundred Thousand and No/100 Dollars (\$2,800,000.00), payable over a thirty-six (36) month period to the UNFIP Trust Fund on behalf of the India Country Team, for the project *Developing Community-Based Adolescent Reproductive Health, Education, and HIV/AIDS Prevention Activities in India*;

FURTHER RESOLVED, that said grant is expressly contingent upon the donation by Government of the Netherlands of Two Million Eight Hundred Thousand and no/100 Dollars (\$2,800,000.00) to the Corporation on behalf of the project, so as to supplement the Corporation's grant of \$2,800,000.00 and to make the total level of support for the project equal to Five Million Six Hundred Thousand and No/100 Dollars (\$5,600,000.00).
