# JMT/UNDP PAR Monitoring and Reporting System

 As part of the technical assistance provided to the PAR Management Committee, the Unites Nations pursued its work with COMSEC's IT Department to complete the automation of the PAR Monitoring and Reporting System previously devised. The System that is based on RBM principles and intended to record achievements and progress against planned results within the PAR Roadmap. In this regards, The system has been fully automated and is currently under testing by the national counterparts

# JP Output 2: GoI has improved public administration systems at national and sub-national levels

# **UNDP: Senior Executive Service (SES)**

- Series of orientation meetings were made with the new secretariat on SES to familiarize the new staff on the roles and responsibilities that are expected from him to support the work of High Committee on SES. It is worth to mention that a group of 15 candidates were selected to enroll in the SES system. The selected group are DGs from various ministries.
- Preparation and consultation was made with senior officials in COMSEC and PMAC to facilitated a mission by the Institute on Governance (IoG) to Baghdad during May 2015 to support the process on first class of SES and the work of Committee as well as the secretariat
- Twenty seven (27) DGs and Ministry Advisors started to undertake an online survey on Executive Leadership Gap Assessment, which shall provide a baseline of the strengths and learning needs of the current cohort of DGs and Special Advisors working in ministries of the Government of Iraq. Each participant in this online survey is asked to provide his/her views on the strengths and learning needs of those holding the title Director General or Special Advisor in Baghdad. Same survey is being made in KRG and it is anticipated to be completed by next quarter

# UNDP: e-Governance:

- At the federal level, a three-day orientation workshop on e-Governance Transformation and e Youth Inclusion was organized for the Ministry of Youth and Sport (MoYS). The workshop was made in Baghdad on Sunday, 18 January 2015 with the participation of over 30 senior staff from MoYS's directorates in the central and local levels.
- The three days' workshop aimed to set the right approach of e-Governance transformation and e Youth inclusion for the ministry; in particular to enhance the participants' knowledge through illustrating the most suitable and adapted directions for mainstream information management and technology and service excellence for youth in the ministry and its transformation mechanism, which will support the reform, and modernization vision and commitment of the ministry.
- Coordination meetings were organized regarding introducing a model on e-Human Resource with the COMSEC that is anticipated to create a national model that once it is succeeded, it can be applied across

other ministries.

#### UNDP-IDMS

 In its technical support to the MoP, UNDP planned to provide four courses of advanced trainings to Iraqi Government users of IDMS. Two out of the four courses were implemented so far by Synergy International Systems Inc, one conducted in Istanbul last year and the second one was conducted in Armenia this year. Two more training courses are scheduled for April this year. The subjects of the courses are: Capital Investment Project Life Cycle, Financial Management and Reporting, and Oracle Administration for IDMS Database

#### UNESCWA

- The previously postponed capacity development workshop is now planned from 20 to 28 April in Istanbul: to be attended by 12 NCMDIT and 7 KIPA participants, the workshop will focus on strategic aspects of change management in support of PAR and IPSM by developing training materials and program. The lead consultant was identified and recruited. The substantive discussions for the workshop have started with the IPSM team, government expert from Lebanon and other potential collaborating agencies. The Project Assistant joined ESCWA in March and has been working on the preparation of the Istanbul workshop.
- The needs assessment and the seminar feedback conducted for NCMDIT before and after the familiarization seminar on KM illustrated the challenges and opportunities in promoting knowledge management at NCMDIT as well as in other government agencies in the context of PAR. Based on the KM seminar outcome, NCMDIT is considering to request for future support, and a similar seminar will be organized for KIPA in Erbil in May 2015.
- In order to implement activities without cost sharing arrangements with Gol, ESCWA submitted a request for budget redeployment which was approved in March.
- ESCWA is also in the process of recruiting the Project Consultant for the documentation and other project management activities.
- From 31 March to 2 April, a familiarization seminar on knowledge management is organized at NCMDIT in collaboration with UNAMI: the seminar will help NCMDIT to develop their knowledge management plan as well as plan future training programs

#### UNFPA

- A consensus was built by both the Central Statistics Office (CSO) and the Kurdistan Regional Statistics Office (KRSO) on areas of and timelines for technical assistance to both offices
- A technical mission by international consultants was conducted for the Central Statistical Organization focusing on details of developing a data centre for the statistical production and data dissemination with special emphasis on the required equipment, installation and operation of the equipment and devices

#### UNWOMEN

- As laid out in the 2015 AWP, measures have been taken to revitalize the National Network on GRB after the new government was in office. The team included different line ministries including MOF, MOH, MOE, MOHS and MOHR with a view to establish a mechanism on the inclusion of gender-responsive budgeting in their budgeting and programming.
- A capacity development workshop was conducted on 12-14 Feb in Baghdad targeting officials from Diwaniya. The objective was to build the capacity of the concerned officials and introduce the concept of gender-responsive budgeting and its implications for gender equality.
- A two-day capacity development workshop on GRB was held in Morocco on GRB. This workshop came to build on the achievements of the regional workshop organized by UNWOMEN in Dec. on GRB. The aim of the second workshop was to consolidate and deepen the participant's knowledge and capacities through a focus on key GRB steps, mainly:
  - Gender-based public policies monitoring and evaluation, and gender-based statistics,
  - Fiscal reforms and public finances management, and
  - Accountability mechanisms and the role of the Parliament.
- o A capacity development workshop was carried out on GRB implementing tools and mechanisms

targeting Najaf governorate officials. This workshop was organized to deepen the understanding of the participants on GRB and to utilize step-by-step application tools. The workshop was very key at this time to advance and leverage GRB application at the regional level after the establishment of the governorate of a "Programme-Based Budgeting" Department including gender-responsive budgeting.

# JP Output 3: Gol is implementing reform and modernization plans in Education, Health and WATSAN sectors

# Education: UNESCO/UNICEF/UNWOMEN

- UNESCO IPSM team held a series of meetings with UNESCO experts during October and November 2014 aimed at discussing the progress of IPSM interventions against the agreed action plan for Q4-2014;
- UNESCO IPSM team held a workshop in Beirut from 28 to 30 Oct with the staff of the Ministry of Education (MoE) literacy team, the MoE Accelerated Learning Program (ALP) team and senior officials from the Directorate General of Educational Planning to:
  - 1. Discuss the scope, functional requirements, and deliverables of a Literacy Education Management Information System (LEMIS) to be implemented across Iraq;
  - **2.** Provide training to Ministry of Education (MoE) Literacy team on the Beta version of the newly developed LEMIS application to identify any gaps in the solution;
  - **3.** Identify the needs and requirements for the Educate A Child Initiative Accelerated Learning Program (ALP); and
  - **4.** Discuss the possibilities, roadmap, and determine an action plan for implementing a new Education Management Information System (EMIS) for 2015 and beyond.

The outcome of the workshop was developing a roadmap for EMIS for 2014 and beyond agreed upon by the attendees

- UNESO IPSM team held a workshop in Beirut from 30 November to 4 December with high level officials from the MoHESR aimed at validating UNESCO 2014 interventions in addition to identifying and developing an action plan for UNESCO 2015 interventions. The following 2014 interventions were validated during the workshop:
  - Developing a methodology for restructuring MOHESR;
  - Strengthening strategic planning, leadership, decision making and communication skills for Iraqi administrative leaders;
  - Promoting academic integrity and codes of conduct in Iraqi universities;
  - Propose appropriate coordination mechanisms between the Ministry of Education (MoE), Ministry of Higher Education and Scientific Research (MoHESR) and the Ministry of Planning (MoP) in Iraq;
  - HEMIS; and
  - Job description development.

As a result, a roadmap for UNESCO 2015 interventions was developed and agreed upon among all participants. The agreed 2015 roadmap includes the following interventions:

- Provide technical assistance to the Committee from Nahrain, Misan and Babylon universities in charge of decentralization towards the independence of universities;
- Establish appropriate coordination mechanisms between MoE, MoHESR & MoP;
- Explore the possibility of implementing a HEMIS pilot project in no more than three universities;
- Undertake a training needs assessment for MoHESR (The MoHESR committee trained in IIEP in 2014 to undertake a training needs assessment for MoHESR);
- Provide technical assistance to the committee in charge of job description manuals in MoHESR;
- Develop content of six interactive e-learning modules on academic integrity and codes of conduct directed to staff, tutors and students. In addition, provide the content of promotional materials regarding academic integrity and codes of conduct;
- Conduct a training on Monitoring and Evaluation; and
- Introduce the concept of Professional Integration and study the possibility of developing this concept practically in the MoHESR and universities.

- In an effort to assist MoE at the Central Government to establish an adequate organizational structure and efficient processes for improved services, UNESCO IPSM team held a workshop in Beirut from 7 to 11 Dec with high level officials from the Directorate General of Vocational Education aimed at grouping the Directorate's tasks strategically in order to develop an initial organizational structure of the Directorate. As a result, the following reports were developed and validated by MoE:
  - Mission and tasks of the Directorate General of Vocational Education;
  - Missions and tasks of the various directorates of vocational education;
  - Initial organizational structure of the Directorate General of Vocational Education; and
  - Internal and external evaluation of vocational schools including the evaluation criteria.

In addition, the workshop aimed at identifying and developing an action plan for UNESCO 2015 interventions. As a result, a roadmap for UNESCO 2015 interventions was developed and agreed upon among all participants. The agreed 2015 roadmap includes the following interventions:

- Establish appropriate coordination mechanisms between MoE, MoHESR & MoP;
- Develop a questionnaire for the pilot activity of implementing an internal evaluation of seven selected vocational schools (four schools in Baghdad and three schools in Salah al-Din, Najaf and Basra governorates);
- Present the goals and tasks of proposed units within the new the structure of the General Directorate of Vocational Education and discuss them with vocational education representatives in MoE;
- Develop Education Information Management System (EMIS) for MoE;
- Identify and extract educational indicators based on the statistical information provided by EMIS in MoE; and
- Provide a best practice guideline for strategic planning using the National Education Strategy (NES) as an example.
- In an effort to provide technical assistance to Basra and Dahuk Technical Universities to establish Academic Integrity Councils (AICs) and students honour societies, in order to promote the concept of academic integrity and raise awareness about codes of conduct among university students, tutors and staff, the following reports/ materials were developed:
  - AICs and students honor societies role on the ground and utilization of materials and online tools in order to promote academic integrity; and
  - Establishment of the AICs and the students honour societies in Basra and Dahuk universities.
- During the reporting period, in furtherance of the reform and modernization plans in education, a consultative forum was organized for a group of experts to review and pretest the training manual for the training of head teachers and school principals on School Based Management and financial administration.
- A total of 16 educational supervisors from 4 provinces (Basra, Najaf, Salahaldeen and Dahuk) that will pilot the School-Based Management approach were trained in Erbil from 21 to 26 October 2014.
- Competent departments in the Ministry of Education deliberated and agreed on the decision-making authorities that should be decentralized to the school level administration to facilitate the improvement of school governance in the framework of the School Based Management approach.
- The final versions of the six studies prepared by international experts were once again reviewed by the EMAC. These reports have now been ratified after the necessary amendments were made.
- Beneficiary SBM pilot schools were vetted, assessed and categorized in an order of priority in terms of level of resources required to effect substantial changes that could make them more child-friendly based on the minimum standards set by the MoE.
- $\circ$   $\,$  The 2015 AWP was endorsed by GoI and shared with the MoE for implementation on mid Feb. this year  $\,$
- All the technical and administrative requirements which related to the training of all categories related to the implementation of the SBM approach in Basra and Najaf completed. The first phase of the training will covered 162 trainees (90 from Basra and 72 from Najaf). The number of the training courses will be 4; 2 in Basra and 2 in Najaf. The training will be cover principals, teachers, accountants and parents.
- o The training manual and SBM implementation guide has been printed and distributed to some SBM

schools.

# Health: WHO/UNFPA/UNICEF/UNWOMEN

- A four-day workshop was conducted in Istanbul on Iraqi National Health aiming to:
  - Review the current situation with focus on key challenges facing the health sector,
  - Review the process and the contents of the draft national health policy,
  - Agree on strategic directions translating the national health policy into action, and
  - Define next steps and the way forward for finalizing the NHP document.
- Preparation is underway to contract Health Care Accreditation Council-Jordan (HCAC) for accrediting 4 Iraqi Primary Health Care Centres (PHCC). The Council which is an external Recognized Accrediting Body is to be contracted to start the process of Accrediting PHCC for the 1st time in Iraq. The process will take approximately 6 months to conclude and will include 4 areas of interventions as follows:
  - Initial Mock survey and Gap Analysis for 4 PHC Centres,
  - Capacity Building of Surveyors,
  - Standards Review, and
  - Final Assessment of the 4 PHC Centres.

# WATSAN: UNICEF/UN-Habitat/UNFPA/UNWOMEN

- The 2015 AWP for IPSM -MMPW Phase II has been endorsed by GoI and shared with national counterparts in mid Feb. In this regards, a series of preparatory meetings were held between UNICEF WASH team and Change Management Working Group to discuss the implementation of the planned activities and the division of roles and responsibilities.
- The national workshop on the draft WATSAN Law for Iraq originally scheduled for the first quarter of the year 2015 will be facilitated by the international consultant during the second quarter and will be organized in Baghdad targeting PMAC and CMWG. Similarly, a sub-national workshop on the same subject will be facilitated by the international consultant during the second quarter and will be organized in Erbil targeting MMT-KRG
- A National Workshop is planned for the second quarter of the year 2015 on draft Strategy Report on Water Quality Management for Iraq. It will, be facilitated by the international consultant targeting PMAC and CMWG. On the same note, a sub-national workshop on the same subject will be implemented in Erbil during the second quarter by the international consultant targeting MMT-KRG

JP Output 4: Gol sub-national governance and decentralized service delivery systems strengthened through enhanced participatory processes

#### **UNDP: eGovernance**

- As part of the e-Governance component under IPSM framework, a mission was made to Missan governorate to provide technical support in moving the new paradigm of integrated e-service delivery and enhancing the capacity of the e-Province execution and transformation, and facilitate the accessibility of e-service and participation of the citizen has been conducted in the governorate during the period of 21 Feb 7 March. This mission was followed with another mission to Basra for the period of 2 4 March to manage the process of roll-out the model of execution and transformation to other local governments.
- One of the achieved milestones during the mentioned mission is that Missan has announced a formal bidding process to go ahead with the execution of e-Missan the National Service Delivery Model. The budget estimated for the mentioned call of bidding is around \$4,000,000. The target date for the online e-services is by mid of quarter four 2015, assuming that this related contact is to be awarded during April.
- Technical support also was provided to the governorate on establishing e-Province team structure and mandates, as well as the methodologies and steps to be applied for enhancing the team capacity. Also an evaluation was made on the current situation of the managerial, administrative and technological aspects of targeted sectorial directorates and entry points for enhancement were identified in the form of a detailed transformation and migration plan for each directory. Technical support and evaluation was also made on the Youth Centers facilities and their operation to be a potential and entry points of Community Service Centers.

- It's worth to mention that the Governor of Missan has provided full support, commitment, leadership, direct engagement with regard of e-Province model and the transforming services online. This was highly recognised as full ownership by the local government to achieve this initiative and provided the sense of urgency by the local authority in Missan.
- As of Basra, it was agreed on moving ahead with the implementation of planned activities during 2014. The development of "Project Management System" was identified for its crucial importance for managing, tracking and monitoring the execution of projects in Basra as the most effective and direct impact system on Basra various stakeholder.

## UNHABITAT

## **o** Stakeholders Workshop at Najaf Water Directorate

On Wednesday, 18 March 2015; The UN-Habitat coordinated the stakeholder's workshop for the Water Reform pilot project in Najaf Directorate. The workshop aimed to ensure the involvement of all related parties and to coordinate with all stakeholders. The project's consultancy group RODECO Consult GmbH presented the project progress and the way forward plan. The workshop was attended by 25 Parsons. In addition to the representative of Najaf Governor, the representative of the ministry of Finance , the representative of the ministry of Planning and the general manager of Najaf Water Directorate.

## **o** Inception Report Workshop at Najaf Water Directorate

On 25 and 26 March 2015; RODECO Consult GmbH, the consultant of the UN-Habitat Water Reform Pilot project in Najaf preformed two days' workshop for presenting and discussing the project's Inception Report. The consultant's team presented their key findings during the inception phase and their approach and methodology to achieve the project's outcomes within the project's time frame. Positive discussions carried out between the Najaf Water Directorate management and the consultant's team which clearly reflected the deep interest of both parties to achieve the project goals. The workshop was attended by more than 42 persons from Najaf Water Directorate, UN-Habitat and the consulting team.

#### WHO

 A contract is being prepared with Australian National University (ANU) for establishing the Decentralization and maintaining an effective health service for Iraq. The main goal of this activity is to conduct visits, assessments, interviews and Focus Group Discussions with key stakeholders including professional syndicates, members of Parliament, decision makers, and different cadres of health work force to determine existing and potential barriers related to the decentralization and suggest appropriate strategies to address these problems.

#### UNFPA

 The 2015 work plan for enhancing youth participation in decision making has been agreed with the Ministry of Youth and Governorates of Basra and Najaf. Areas of technical support for this process and other processes have been agreed between the Ministry of Culture and Youth together with the American University of Beirut.

#### Main implementation Constraints and Challenges

#### UNDP

• At regional level, and despite the most recent initiative led by UNDP to advocate for the importance of the KPSM with the Minister of Planning in KRG, the project document is still pending approval and a clear political endorsement.

#### UNICEF

- Due to the current financial crises in Iraq, IPSM is expected to receive less if no GoI financial support, thus limiting the chance of implementing agreed upon joint activities as highlighted in 2015 AWP
- The prolonged delay in receiving the feedback of PMAC and CMWG on the shared draft reports and studies
- The delay in receiving the entry VISA to Iraq for the internationally recruited consultants, and also entry

visa to other countries for the Iraqi trainees

#### **UNESCO:**

- Inability of national counterparts to utilize the remaining 2013 parallel funding due to the delay in endorsing Iraq's 2014 National budget.
- Deteriorated security situation after a significant period of the reported steady improvement in the past years.

# WHO

• The conflict happening in MOH regarding the presence of 2 committees, headed by 2 different MOH deputies with 1 team/each, dealing with the same topic (I-PSM & PAR).

# UNFPA

• The reporting period was mainly utilized for sourcing technical assistance and making consensus on plans for 2015. Little progress was therefore made on implementation of actual activities

## UNWOMEN

• Short of resources and lack of funding on the part of the government due to recent austerity measures by the government made UNWOMEN meets most of the costs of training sessions and workshops.
