#### 1. Introduction

On Wednesday October 23<sup>rd</sup>, the Unihouse Team met with UNDP Project Team and BDS Team via Skype from Basra. The meeting was organized to discuss the project status and the Rapid Market Survey results. In addition to that, the following points were discussed:

- 1. The section criteria
- 2. Type of new businesses suggested by the team
- 3. Authenticity of information collected from the village Sheikhs
- 4. A wider market research was needed to cover the whole market
- 5. The number of participants that attended and the way they were invited
- 6. The selection process and the possibility of considering a fast track approval
- 7. Training on how to prepare the feasibility studies/business plans for the pre-selected beneficiaries
- 8. Vocational training and local apprenticeships
- 9. Collecting of the feasibility studies, verifying completion and providing them to UNDP/Shell



After a lengthy, constructive discussion, a new action plan/road map (attached Gantt sheet) was created and agreed upon by all team members. The Unihouse Team needed to pre-select the potential participants from the total applications that were collected during the team's first visit. The original selection criteria were simplified in order to give as many applicants the chance to benefit from the program. The pre-selection was completed and a copy of the participants' names (attached) who will be attending the upcoming feasibility study/business plan training was sent to UNDP.

On Friday October 25<sup>th</sup>, Mr. Jan sent an e-mail requesting clarification on how the beneficiaries were selected by Unihouse. Unihouse provided an explanation in response (attached) to Mr. Ian's request.

On Sunday October 27<sup>th</sup> a follow up meeting was organized. The Unihouse Team and UNDP Project Team attended. The BDS team did not attend. The purpose of the meeting was to discuss the upcoming Unihouse Team trip to Basra that was scheduled to take place on October 30<sup>th</sup> and 31<sup>st</sup> where the new action plan/road map would be implemented.

On Sunday October 27<sup>th</sup>, the Unihouse Basra Local Team was mobilized and instructed to:

- 1. Contact Al Nashwa City Council and inform them of the upcoming visit
- 2. Ask for council involvement and assistance to inform all selected beneficiaries
- 3. Prepare for all logistics such as:
  - a. food (lunch and tea breaks)
  - b. data show and stationeries
  - c. meeting room/hall
  - d. diesel engine power generator
- 4. Stay in contact with all beneficiaries during and after the training is completed

## 3. Feasibly Studies/Business Plan Training

A basic training on how to prepare the feasibility studies was conducted. The training material that was previously sent and approved by UNDP and BDS was used. Participants took part in two days of training that included a balance of lecture, discussion, group work and hands-on activities. They had to write parts of the feasibility study which were reviewed by our experts. At the end of the training workshop, participants were given a simple survey that had previously been viewed and discussed by UNDP. Participants filled out the survey that identified their future training needs. (The training need results are attached.)

Frain. Develop

After the training was completed, all participants were told that they were required to complete the feasibility studies/business plans by Friday November 8<sup>th</sup>. Participants were informed that the Unihouse Local Team stand ready to provide assistance if need be.

Once the feasibility studies/business plans are collected, the Unihouse Team will do the following steps:

- 1. Verify that the collected studies are complete
- 2. Type the studies on Microsoft Word format as it is difficult to read handwritten documents
- 3. Translate some or all into English if required, however, this task will require additional time which will delay submission dates



### 4. <u>Review of Feasibility Studies/Business Plans:</u>

A team consisting of UNDP, Shell, Unihouse and BDS will review the submitted feasibility studies/business plans. During the selection phase, consideration must be placed on:

- the geographical location of the selected businesses
- type of the businesses
- pre-selected social sectors (women, handicapped and craftsmen)
- the dire need of the applicant for income

Once all feasibility studies/business plans have been, a few will be selected and approved. As discussed during our October 23<sup>rd</sup> meeting, some beneficiaries may be required to present their cases in front of the review committee.

### 5. Entrepreneurship Training:

All selected businesses (men and women) will have to sit in on and participate in entrepreneurship basic business trainings. The duration of the training will be 24 hours broken up over 3 to 5 days depending on the participants' learning needs. The training must be conducted in a professional training venue as opposed to the local gathering place where we were required to interview and train at August and October 2013. The training should be conducted In Basra or out of Al Nashwa area, so that participants are focused on and actively engaged in their training.

For vocational businesses, we suggest two approaches:

- 1. Apprenticeship Program
- 2. Vocational Training Program

Both programs are costly and need proper funding to be successful. We will discuss such programs once we get closer to implementation.
