#### **State owned Enterprises Restructuring**

- Roadmap for SOEs Restructuring approved by Cabinet decision #314/210 and published (UNDP/UNIDO) in 2011;
- SOE Classification Toolkit, Terms of Reference for Restructuring Units and Support Teams, training and asset valuation guidelines delivered;
- Asset valuation unit established in the Ministry of Finance with WB's support
- ID 100 billion (about US\$ 85 million) for SOEs Restructuring allocated on Federal budget in 2012;
- Social Mitigation Programs for the 3 SOEs, Glass and Ceramics in Anbar, Petrochemical and Paper in Basrah released and distributed to the related stakeholders on July 2012 (UNIDO);
- Draft Feasibility Studies for the 3 SOEs, Glass and Ceramics SOE in Anbar, the Petrochemical SOE and Paper SOE in Basrah completed and under final review in order to be submitted by end of 2012 (UNIDO).

- SME Package: Policy Framework, Draft Law and TORs for MSME Agency submitted, training by PARP Government of Poland (UNDP)

  - Three SME Surveys completed to assess informality, insertion in supply/value chains challenges, regulatory needs. Final reports are being drafted
- UN Women Developed a report that included guidelines and recommendations on SME policy
- Micro finance policy forum: April, 2012 (UNDP)

#### **Investment Policy**

- Investment Map delivered, inlcuding sector and investment profiles in selected governorates (Baghdad, Najaf, Erbil, Anbar and Basra)
- Formulation of final draft Iraq's Industrial Strategy and Strategic Governance System by the MoIM under UNIDO Training & Coaching assistance; 4 workshops held in Bratislava (May 2011), Istanbul (August 2011), Dublin (December 2011) and Tunis (April 2012) concluded in August 2012 for a final draft of the Industrial Strategy inclusive of distinguished vision, policies and action plans related to the support of PSD strategy (UNIDO).

#### Land Management Reform

- Consensus on land policy process; Land Reform Vision Statement and Road Map; TORs prepared for key policy studies (UN-HABITAT).
- Draft Order established for the establishment of a land policy advisory commission.
- Study on urban land tenure and policy papers on state land management and fragmented land ownership prepared and delivered; Land Governance Assessment underway; State Lana Management Policy Draft underway
- Recommendations provided to WG on establishing a state land inventory, simplified land/property registration procedures, land valuation; land inventory pilot underway

#### **Tax & Financial Policy**

- Tax Regime Reform Strategy first draft prepared (UNDP).
- Cooperation framework with OECD, USAID and Government of Romania concluded.

#### Social Dialogue

- National Conference on Economic Reforms Tripartite Agreement (GOI, Employers and Unions) signed off.

#### Gender

- UN Women prioritized five core areas that need to be reviewed from a gender perspective: Labor Law, Civil Code, Economic Reform Law, The basic legal framework (Constitution and Civil Code), and Retirement and Social Security Law Those areas were prioritised as they influence women's economic empowerment and equal opportunities particularly in the private sector. UN Women developed guidelines on how to sensitise Gender in the Legislation Drafting Process.
- Business Women Association
   UN Women in close coordination with the State Ministry of Women's Affairs is
   conducting a consultation meeting with 35 Iraqi businessmen and women to
   agree how to establish an Iraqi Businesswomen's Association.



#### **Down Stream Activities**

- Successful Implementation of the Business Packages (unemployed youth, contractors, women economic empowerment- training delivered to 1052 trainees (21% women) etc
  - Micro finance: 1<sup>st</sup> tranche to MFIs (2 in Basrah and 1 in Anbar) completed. 2<sup>nd</sup> tranche is under review in Anbar. Erbil identified 2 MFIs for 1<sup>st</sup> tranche (UNDP)
- Support to Economic Development Planning: Groups of Experts trained and mentored on how to identify and plan economic development projects. Reports on the economic situation and opportunities ready to be validated by public and private sector stakeholders (ILO/UNOPS)
- Business Development Services : Business Information Centers fully furnished and provided with ICT equipment, training needs assessed and training materials being developed on how to develop a business plan, a marketing strategy and a financial sustainability plan for 2013; day-today mentoring etc (ILO/UNOPS)
- SoEs: Downstream support activities of 3 SOEs in Anbar/Basrah for restoring their competitiveness and market position focusing on capacity building in the fields of Productivity & Competitiveness, international marketing also in creation of partnerships dialogues with international companies. Implementation of partial rehabilitation of the SOEs including some procurements under completion (UNIDO)
- Electricity distribution master planning activities with trainings are on-going in Anbar and Basrah. Erbil launched request for proposal for down stream activity in September. The preliminary findings and recommendations under SEINA were delivered (UNDP)

- Increase of "training" budget line (15%)
- Increase of "other direct costs" line (6%)

UNDP (Last budget revision in May 2011)

- Increase of "Personnel" (6%) and "Other direct costs (life support cost etc)" (100%) budget line due to 1 year programme extension
- Increase of "Training" budget line (39%) with more capacity development supports facilitated and provided
- Decrease of "Supplies, commodities, equipment and transport" (32%) and "Contracts" (38%) budget line because micro finance component cannot be implemented as planned

  - Estimated duration: 3 years
  - Estimated total budget: US\$ 26,800,000
  - Requested Gol contribution for 2012: US\$ 2,187,000
  - UN contribution for 2012: US\$ 805,000
- Objective: creation of jobs in the private sector, through more competitive SMEs
- The joint program will particularly, though not exclusively, target vulnerable women in urban areas with a view to empower them economically and socially
- Project components: business development services, entrepreneurship training, vocational skills training, micro-credit for business start-ups, literacy literacy and reproductive health issues, training and support to community leaders on awareness raising on women Human rights, including their Reproductive health and GBV concerns (UNWomen, UNFPA).
- Implementation will be guided, among others, by the findings and recommendations of the ILO/UNOPS survey on informal SMEs in Iraq, which will contain a section on the barriers faced by women in starting and running a business
