BACKGROUND

The funds to be provided under the umbrella project are the result of accumulated interests earned of UNDP Country Office Programme resources. The Funds will be utilized to strengthen programme identification/formulation, provide the Government counterpart (Ministry of Planning and Internations Cooperation) with highly qualified expertise needed for development planning and carry out critical projects' activities for which no project resources are available. The Project will support awareness creation of human development issues, coordination of new initiatives and build capacities of UND programme and counterparts' staff and provide required technical advice/inputs to UNDP Jordan of specific issues in line with the national priorities.

As recommended by the Country Programme Mid-Term Review exercise conducted in mid 2005 strengthening national counterparts' capacities in UNDP programming using NEX, financial procedure and reporting is essential. To this end, a number of workshops, seminars and meetings will be organize to meet these needs ultimately ensuring effective and efficient implementation of UNDP Nationall Executed (NEX) projects in Jordan.

UNDP Country Office will be formulating the new Country Programme for Jordan during 2006-200 based on the Common Country Assessment (CCA) document. This exercise will require the utilizatio of expertise to support the development of UNDP's areas of intervention in accordance with the, to be agreed upon by end 2006, United Nations Development Assistance Framework (UNDAF), Result Matrix and the Monitoring and Evaluation Plan. The next UNDP Country Programme for Jordan will be prepared according to the new Results Based Management (RBM) guidelines. The new Country Programme for 2008-2012 will be reflected in the UN Country Programme Document (CPD), the Country Programme Action Plan (CPAP) and the Annual Work Plans (AWPs) with corresponding outcomes, outputs, indicators and to be achieved targets.

OVERVIEW

This umbrella project intended duration is for three years period (September 2006 – end 2009), covering the current and the preparations for the next UNDP Programming Cycle (2008 -2012), with possibility of extension if proven successful. The purpose of the umbrella project is to support the effective and efficient implementation of the UNDP Country Programme of Jordan. The overall objective of the umbrella allocation is to enable UNDP Jordan Country Office to provide enhanced support to the formulation and implementation of Nationally Executed Projects (NEX), which attainment will directly impact the operationalization of the National Agenda Implementation Work Plans hence contributing towards the achievement of the Millennium Development Goals (MDGs) in Jordan.

The proposed areas of support are:

To enable UNDP supply for requested highly specialized technical expertise to projects that are providing macro level multi-sectoral and multi-dimensional support to the Government (such as Early Warning System and Support to the Department of Statistics). Priority will be given to support efforts in collecting, analyzing and compiling baseline data required for MDGs and the National Agenda Implementation Work Plans implementation, monitoring and progress reporting at the national and local levels.

To enable UNDP Country Office draw upon services of long term national expertise and Programme staff, to enhance the capacity of the Country Office at crucial Programme formulation and implementation phases to ensure quality aspect of its programme/project design, formulation and effective implementation.

To enable UNDP to respond to justified requests from the Ministry of Planning and International Cooperation for policy level advice, beyond the scope of the current on-going UNDP projects, by using short-term high caliber expertise to carry out needed specific technical studies/researches and capacity building activities.

To enable UNDP to draw upon short term international and national expertise to conduct capacity assessments, technical assistance Programme identification and development that will contribute towards the formulation of the new Country Programme and the realization of its goals. Such services will be specifically needed to support:

- The formulation of UNDP Jordan new Country Programme Cycle (2008 2012). Since UNDP will be moving towards the Programme Approach instead of the current prevailing project approach, multi-sectoral expertise will be required to prepare for the key UNDP intervention areas within the framework of UNDAF.
- The formulation of indicators framework for the UNDP Jordan projects/programmes to be prepared under the new cycle as well as data collection mechanisms for effective monitoring of projects/programmes results/impacts. This is in line with the new Results Based Management methodology adopted by UNDP.
- The formulation of a new comprehensive National Execution Modality (NEX) manual in line with the new UNDP guidelines and the ATLAS work environment.
- The formulation of UNDP Resource Mobilization Strategy for the new Programming Cycle





To enable UNDP Country Office to carry out one Programme outcome level evaluation per year as recommended by the Assessment of Development Results mission carried out in June 2006 and to meet the requirements of UNDP Evaluation Office.

To enable UNDP to support local media capacities and enhance their role to promote Human Development policies, values, activities and achievements in Jordan.

To build the capacity of the UNDP Programme and national counterparts in issue related to planning, costing/budgeting, monitoring, evaluation, resource mobilization and mainstreaming gender and human rights into development.

UNDP 11888 Fund Inputs:

Short Term Experts Costs (US\$ 150,000): To cover the costs of services of short term international/national expertise.

Personnel Costs (US\$ 100,000): To cover the cost of long term personnel to improve the formulation, implementation and monitoring of the different projects supported by UNDP Country Office in Jordan.

Learning Costs (US\$ 30,000): To cover the costs of participation in capacity development workshops and seminars as well as missions to be undertaken by UNDP Programme staff and relevant national counterparts. Also to cover the costs of meetings and seminars on admin/finance and programme issues that would facilitate better programme/project implementation and delivery.

Awareness raising (US\$ 20,000): To cover the costs of awareness raising and media campaigns on Human Development activities and achievements in Jordan and support the capacity development of media personnel on development reporting.

Implementation Arrangements:

The Project will be Directly Executed (DEX) by UNDP. The recruitment and procurement of services will be conducted in accordance with UNDP's rules and regulations. UNDP will provide the Ministry of Planning and International Cooperation with an annual progress report and semi annual expenditures statement, the Combined Delivery Report (CDR).
