The Project set out the following activities which will contribute to the gender equality and women's empowerment:

PUNO collaborate and engage with Government on gender equality and the empowerment of women (The programme contributes to substantively strengthen Government participation and engagement in gender related SDGs localization and/or implementation; Through the INFF initiative one concrete entry is the gender-responsive SDG budgeting, as such, we can ensure that the aim of the proposal is to anchor the SDGs, including SDG 5 on gender, into the budgetary systems and processes being adopted. The

budget provides for comprehensive training activities on gender-responsive SDG budgeting to both MinFin staff involved in the budgeting process as well as relevant stakeholders working on gender equality in Kazakhstan.

Program proposes a gender-responsive budget (Criteria: At least 30% of the total budget is allocated to gender equality or women's empowerment. 43% of the JP's total budget is allocated to gender equality.

#### Briefly describe in the space below how the Project mainstreams environmental sustainability

According to the results of RIA of the national budget conducted in 2019, some SDGs, including SDG 13 are not well-funded by the national budget. Related sectoral plans remain unclear about how they will effectively mobilize additional sources of SDG – aligned financing. Therefore, attention of the Project will be brought to those areas where climate change could have a larger impact and examine the social safety nets for the communities. The Project will increase available fiscal space and potential to expand financing solutions for social expenditures, such as, for example, by attracting under-exploited climate finance.
