Summary Report for the audit of Amkeni Wakenya Grantees Funded by UNDP for the period January 2012 to June 2014.

Executive Summary

The Amkeni Wakenya Civil Society Democratic Governance Facility ("Amkeni Wakenya" or "The Facility") is an initiative established by development partners including The Royal Netherlands Embassy, the Embassy of Sweden, Royal Norwegian Embassy (Norway),European Union (EU) and the United Nations Development Programme (UNDP) to provide co-ordinated and harmonized support to civil society organizations (CSOs) in the democratic governance sector in Kenya to participate more effectively in democratization processes in Kenya.

The overall objective of Amkeni Wakenya is to support civil society organizations (CSOs) that work in the democratic governance sector in Kenya by enabling the CSOs to work for, demand and benefit from a more accountable ,just, transparent and democratic society that upholds respect for human rights and fundamental freedoms.

The audit sought to obtain an assurance on the adequacy of management and oversight of the project and on the use of resources. Specifically, the audit was to provide assurance to UNDP, the project management, and other interested parties that project resources are being managed in prudent manner and in accordance with financial regulations, rules, policies and procedures laid down for the projects. The scope of the audit included all the 276 grantees implemented by 175 implementing partners and covered the period 1 January 2012 to 30 June 2014.

The audit entailed a financial audit to express an opinion on the project's financial statements that included:

- A) The FACE Forms
- B) Statements of cash positions
- C) Statement of assets and equipments

In addition we assessed and expressed an opinion on the project's internal controls and systems on each of the implementing partners as out lined below save for 15 implementing partners whom we could not access.

Summary of Findings

- 1. A total of six implementing partners were late in submission of both the narrative and the financial reports.
- 2. Sixteen implementing partners did not carry out monthly bank reconciliations
- 3. Three implementing partners did not have their vouchers invalidated by being stamped with paid up stamp
- 4. Three implementing partners had their assets not tagged/marked with UNDP tags

Recommendations

- 1. The affected implementing partners should ensure strict adherence to the reporting guidelines as outlined in the cooperation agreement.
- 2. In keeping with good accounting practices, bank reconciliations should be carried out regularly preferably on a monthly basis and reviewed by a person independent of the reconciliation process.

- 3. Vouchers should be cancelled upon payment to avoid any possibility of multiple payments on the same vouchers.
- 4. Implementing partners should tag/Mark the assets procured by UNDP funds for control purposes.

INTRODUCTION

1.1 BACKGROUND

Amkeni Wakenya is a UNDP led facility set up to promote democratic governance in Kenya. The name "Amkeni Wakenya" is inspired by the second stanza of the National Anthem that calls upon all Kenyans to arise and actively participate in nation building. Amkeni Wakenya was established in July 2008, and then known as the "Civil Society Democratic Governance Facility (CSDGF)" and works through Civil Society Organizations to promote democracy, human rights, governance reforms, and the integration of a right- based approach in social and economic reforms in Kenya. Participating development partners include the Royal Netherlands Embassy (RNE), the Swedish Embassy, Embassy of Norway, the European Union, Embassy of Japan and the United Nations Development Programme (UNDP). At the time of inception Amkeni Wakenya operated on the basis of three pillars, namely grant making, capacity building and learning & knowledge management; however these pillars have since been modified in the Amkeni Strategic plan 2011-2015 and are known as programme delivery methodologies.

At the time of its inception, the Amkeni project sought to set up a facility to support civil society activities in democratic governance. The long term outcomes of the project are to enable citizens to benefit from a more accountable, just, transparent and democratic society and to support civic engagement which empowers the citizens to influence public policies. The project supports activities to strengthen participatory democracy, social justice, the rule of law and protection of human rights and facilitate citizens' active engagement in governance reforms and development processes.

Specific outputs of the programme include:

- Operational mechanisms for channeling support to civil society organizations in the area of democratic governance established
- Civil society engagement in national development objectives and reforms in other priority areas in the democratic governance field strengthened
- Coordination of donor support strengthened

- Principles of organizational good governance practices adopted and implemented by participating organizations
- Public debate and civic awareness on result areas increased, leading to a more informed and participative citizenry, including in rural and remote areas
- Structured dialogue between donors and civil society enhanced

The Overall programme objectives are:

- To enable citizens to benefit politically, socially and economically from a more accountable, just, transparent and democratic society that upholds the respect for human rights and fundamental freedoms
- To support civic engagement, which empowers all people to influence public policies, through their civil society organizations at all levels

The Specific programme objectives are:

- Strengthen participatory democracy, social justice, the rule of law and protection of human rights
- Increase organizations' internal good governance practices (against established benchmarks and as part of the capacity strengthening)
- Promote and facilitate citizens' active engagement in development processes and their capacity to take action
- Transmit citizens' concerns and ideas to local governance institutions and elected parliamentarians, appropriate parliamentary committees, committee staff and reform institutions
- Enhance a two-way communication flows between rural and remote areas/actors and national development processes.

Amkeni Wakenya seeks to promote democratic governance reforms through supporting civil society organizations. The nature of support extended to civil society organizations by Amkeni Wakenya is through: Grant making, capacity development and learning and knowledge management. Since its inception Amkeni has managed to provide grants to CSOs and CBOs country wide through successive calls for proposals. So far Amkeni has published five calls for proposals and supported over 200 civil society organizations to undertake democratic governance reform initiatives mainly in the rural areas.

1.2 AUDIT OBJECTIVES

The objective of the audit was taken to obtain assurance on the adequacy of management and oversight of the project and on the use of resources. Specifically, the audit was to provide assurance to UNDP, the project management, and other interested parties that project resources are being managed in accordance with:

- The key considerations in the areas of human resources, finance, procurement, assets management, cash management and general administration;
- The financial regulations, rules, policies and procedures that applied to and have been prescribed for the projects;
- The project work plan, progress reports, project resources, project budget, project expenditure, project delivery, recruitment, operational and financial closing of projects and disposal or transfer of assets.

1.3 SCOPE AND METHODOLOGY OF THE AUDIT

We conducted our audit in accordance with International Standards on Auditing. The scope of the audit was limited to the implementing partner expenditures which are defined as including all disbursements listed in the quarterly financial reports submitted by the implementing partner and the direct payments processed by UNDP at their request. The audit covered the period 1 January 2012 to 30 June 2014. A hundred percent review of the areas reviewed was applied.

Our audit covered the following areas:-

a) Audit of the funding Authorization and Certification of Expenditure (FACE) Form

Our review of the Funding Authorization and Certification of Expenditure (FACE) Form entailed the following:-

• Verifying the mathematical accuracy of the FACE form by ensuring that the expenditures described in the supporting documentation are reconciled to the expenditures, by disbursing source, in the FACE form.

- Reviewing both the final and the quarterly financial reports submitted by the implementing partners by reconciling them to the supporting documents.
- Reviewing any direct payments processed by UNDP at the request of the implementing partner to supporting documents and verifying that they were adequately supported, authorized and correctly allocated.

b) Review of the overall management of the project's implementation, monitoring and supervision.

The audit included the review of work plans, progress reports, project resources, project budgets, project expenditure, project delivery, recruitment, operational and financial closing of projects (if applicable), and disposal or transfer of assets. To this effect, the scope covered the following areas as they were performed at the level of the project:

Human Resource

We reviewed the competitiveness, transparency and effectiveness of the recruitment and hiring of personnel at implementing partner's level. Our review included performance appraisal, attendance control, calculation of salaries and entitlements, payroll preparation and payment, and management of personnel records.

Finance

We reviewed the adequacy of accounting and financial operations and reporting systems. Our review included budget control, cash management, certification and approval authority, receipt of funds, and disbursements of funds, recording of all financial transactions in the expenditure reports, record maintenance and control.

Procurement

We reviewed the competitiveness, transparency and effectiveness of the procurement activities of the project in order to ensure that the equipment and services purchased met the requirements of either the implementing partner or UNDP. Our review included the following:

- As applicable, delegations of authorities, procurement thresholds, call for bids and proposals, evaluation of bids and proposals and approval/signature of contracts and purchase orders;
- Receiving and inspection procedures to determine the conformity of equipment with the agreed specifications and, when applicable, the use of independent experts to inspect the delivery of highly technical and expensive equipment;
- Evaluation of the procedures established to mitigate the risk of purchasing equipment that do not meet specifications or is later proven to be defective;
- Management and control over the variation orders;
- The use of consulting firms and the adequacy of procedures to obtain fully qualified and experienced personnel and assessment of the work before final payments are made.

Cash Management

We reviewed all cash held by the project and procedures for cash safeguarding.

General Administration

Our review included travel activities, vehicle management, shipping services, office premises and lease management, office communication and IT systems and records maintenance.

Scope limitation

Transactions/actions that are performed by the UNDP/Amkeni Wakenya office for its running costs, capacity building and knowledge management activities are not to be included in the audit scope. Such scope limitation will not be a reason for issuing modified opinion.

Qualified opinions

Qualified opinions were issued in respect of 13 organizations mainly because these grantees could not be met on the scheduled days for various reasons such as:

- 1. Inaccessibility of office locations due to insecurity arising from terrorism. This was mainly the case for organizations based in Northern Kenya.
- Unavailability of the grantees' officials to meet with the audit team on appointed dates. Various reasons were given for this including emergence of other engagements. Even though the PMU managed to reschedule these visits subsequently, it was not

possible for the auditors to make return visits because of limited time for the assignment as well as financial implications of the rescheduling.

- 3. Changes in information regarding the physical location of the grantees' offices from the information provided to the PMU.
- 4. Loss of project records by grantees. This was the case for grantees that implemented shorter projects (Call 5- WRIP and QRF- SODNET.)
- 5. In one case, Centre for Human Rights and Democracy (CHRD) the officials of the organization declined to meet with the auditors claiming that they had not received official communication about the audit from UNDP.
