- The project directly contributes to achieving SDGs #1; #4; #5; #8; #10 and #16 and is fully aligned to UN/DP and the Government's plans and priorities: Government's Youth Development Strategy and the United Nations Youth Peace and Security (YPS) & Women Peace and Security (WPS) agendas.
- Confirm contextualization of the proposed interventions and reconfirm national ownership and buy-in.
- Advise on next steps in the approval process and if the project is recommended to be approved, further amended/revised or rejected.

Background information on the Project

**Project Title:** Economic empowerment of youth and developing sustainable solutions for youth's entrepreneurship at the local level for fostering greater social cohesion and resilience (hereinafter as to Economic empowerment of youth)

**Duration:** April 2022-March 2025 **Project Budget:** 2,000,000 US dollars

Implementing Partner: UNDP in the Kyrgyz Republic

The main goal of the project is to minimize youth's socio-economic exclusion to foster social cohesion by improving entrepreneurial ecosystem and entrepreneurial skills, increasing civic participation of youth and interaction with local authorities in youth's well-being

To achieve this goal, the project will be implementing three components as specified further:

Component 1. Formation and improvement of local mechanisms, tools and institutions that
foster an integrated approach to the development of youth green entrepreneurship and
entrepreneurial ecosystem

- Component 2. Enhancing job and income opportunities through education, business support and mentorship programmes
- Component 3. Empowering youth through digital skills training that fits the needs of employers in the creative economy

The Project Document "Economic empowerment of youth" was shared with all LPAC members prior to the meeting, for their review, consideration and comments. The Project Quality Assurance and SES (Social and Environmental Screening) were completed at the final design stage. Gender marker is GEN2.

# **SUMMARY OF LPAC DISCUSSION:**

- The project is fully aligned to the Government national priorities and directly contributes to achieving SDG goals #1; #4; #5; #8; #10 and #16. The project will have an impact on youth's empowerment, well-being and development.
- UNDP emphasized the role of the *Government* in ensuring effective collaboration with the project and securing political leadership and national ownership of the project implementation.
- The *Government* expressed its gratitude and appreciation to UNDP and the *Donor* for continued support to the socio-economic development of the Kyrgyz Republic.
- The *Project* was presented by Senior Advisor on Social Cohesion (*Project Manager*), *Mr. Mukash Kaldarov*. The presentation covered key objectives of the Project, other relevant project information, outcomes and outputs, overall targets, partnership, project structure and summary of the budget.

#### **RECOMMENDATIONS:**

- The Project Document was translated into Russian and was circulated among LPAC meeting participants beforehand along with invitations. During the LPAC Meeting it was recommended to share with presentation made to receive additional comments and suggestions to the project. The presentation was shared thereafter among all participants.
- The Deputy Minister of Culture, Mr. Nadyrbekov recommended to review the target locations based on the priorities of the Ministry.

# **Conclusion done by LPAC Committee:**

- 1. All recommendations made are accepted as presented.
- 2. Following the discussions and given the importance of the project to the country's development, participants have jointly agreed to endorse the Project Document
- 3. Participants were informed that if they have any other comments and suggestions, they still can send them to Programme staff for which UNDP will share a power point presentation
- 4. The questions raised by the LPAC participants were mainly related to implementation stage, namely to AWP planning, so to specify actions and ensure greater synergies with the ongoing plans and priorities of the Government.

## Follow up actions and key results:

- 1. UNDP circulated a power point presentation for possible comments and suggestions by the participants
- 2. Based on the received comments and suggestions to complete the Project Document

- 3. UNDP organized bilateral meeting with the representatives of the Ministry of Culture. The suggestions raised during the meeting were further officially submitted to UNDP (letter dd. Feb 24, 2022, with ref # 15-3/845 attached), which include:
  - O To consider mutli-ethnic administrative centers such as **Jalalabat city**, **Uzgen** (instead of Kurshab village municipality), **Nookat** (instead of Isanov village municipality), as target locations for youth centers that can simultaneously serve as district level youth platforms.
  - To include activities aimed at analyzing policies and programs and refining legal framework to ensure sustainability of youth centers and effective implementation of youth policy at the local level.
  - O To support the development of an electronic platform (website) to ensure greater coordination between state authorities and partners while implementing youth policy.
- 4. The suggestions of the Ministry of Culture have been accepted and reflected in the Project Document in the following way:
  - Jalalabad, Uzgen and Nookat cities included into the Annex C 'Target Locations' of the Project Document
  - Refining legal framework and electronic platform (website) integrated with the Activity
     1.1 on "Establishment and strengthening of existing local mechanisms, tools and institutions"

## Annex 1: Detailed record of LPAC Meeting

The LPAC meeting was chaired by Ms. Monica Rijal, UNDP DRR in the Kyrgyz Republic.

The LPAC meeting was moderated by Ms. Erkina Urazbaeva, Team Leader of UNDP Accountable Institutions, Justice and Peace Cluster. The moderator welcomed all the participants and introduced the agenda of the meeting. The meeting was attended by representatives of key national implementing partners. The moderator informed that the appraisal meeting provides an opportunity for the committee members to review and discuss project outcomes, activities and requested the members for feedback and endorsement of the project document as an outcome of the appraisal meeting.

# Welcoming speeches by:

Mr. Romanov Artem Sergeevich (First Secretary of the Embassy of the Russian Federation), welcomed and congratulated members on the start of a new project. He expressed satisfaction that the Russian Federation continues its interaction with UNDP in the Kyrgyz Republic, several projects have already been implemented and the joint portfolio is replenished with a new project, which is aimed at improving the economic and professional conditions for young people. He emphasized that the project was very carefully worked out and discussed by Russia - Trust Fund – UNDP. He noted that interacting with all UN structures implementing projects with the financial support of the Russian Federation in the Kyrgyz Republic, for instance UNODC. There is a positive trend towards work with youth. The more support in the field of business development, support for start-ups and, in general, the conditions for professional development for young people, the less the risks of organized crime, extremism, and drug trafficking will be. The comprehensive efforts undertaken by the UN agencies in the Kyrgyz Republic are a good start for the future. The project, both in terms of coverage of women and young people, as well as geographical coverage, is quite impressive.

Mr. Nadyrbekov Soyuzbek Nadyrbekovich (Deputy Minister, Ministry of Culture, Information, Sports and Youth Policy of the Kyrgyz Republic): "Dear partners, I am currently on a working trip to the regions of the Kyrgyz Republic and, first of all, I want to thank you for what you have done already because, now touring the regions and districts, we see that the youth centres that we opened earlier together with you are functioning very well, there are a lot of youth. Wherever we go, the question of new youth centres and opening opportunities are raised. Young people really need such a space, and now such spaces are being used to discuss and implement their ideas. As a ministry responsible for youth policy, we pay attention to the consistency and sustainability of all youth-related projects. We want to develop a model regulation for youth centres and resolve issues with funding. LSGs are ready to allocate funds for the development of youth policy at the local level, but there is no legal basis. We hope to meet with partners after completing the trip to all regions of the Kyrgyz Republic. I would like to once again thank our partners for cooperation!".

Ms. Monica Rijal (UNDP DRR in the Kyrgyz Republic) thanked national partners, meeting participants for cooperation and highlighted the importance of the project. She stressed that for the UNDP in the Kyrgyz Republic as well as for all participants of the LPAC this is a significant step forward to youth support in the Kyrgyz Republic. UNDP in the Kyrgyz Republic has a longstanding and successful partnership with Russian Federation. More than \$13 M has already been allocated so far to sustainable development focusing on SDGs is core to what UNDP does in Kyrgyzstan. But more than that we work with Russian expertise on demand in support of national capacities. Today, UNDP is pleased to present the project on "Economic empowerment of youth and developing sustainable solutions for youth's entrepreneurship at the local level for fostering greater social cohesion and resilience". Out of this project's title, there are three takeaway words to be drawn: youth, social cohesion and resilience. The project was approved by the Russian Federation for \$2 M, which is highly commendable, especially in times of global crisis.

I want to remind of certain data that we should be reminded of. One-third of the global youth lives in fragile and conflict countries and this number is expected to increase from 1.6 to 3 billion by 2030. It is actors like ourselves

in partnership with civil society, governments, private sector, that can disrupt the progression towards this number. Since 2015 world leaders have recognized that young people are key actors in building sustainable development and peace. However young people are also largely marginalized and excluded from social and economic opportunities, political processes. Socio-political and economic inequalities, governance issues, growing tendencies of violence, global and local crises, pandemics, political instabilities, lack of access to jobs and other opportunities are all the factors that don't allow young people to advance nor to contribute to political processes.

As UNDP, we strongly believe in young people's power and leadership in mobilizing movements and networks, speaking truth to power, proposing innovative solutions to complex development challenges, and driving effective grassroots action for peace in their communities. The project to be presented today is precisely aimed to support youth civic participation and empowerment for sustainable development and peace because we believe that youth innovation, creativity and motivation can play a transformation role and accelerate role in local development. However, lack of enabling business ecosystem at a grassroots level and limited access to capital, insufficient tools are also big challenges and these challenges don't allow young people to contribute to development. So as a response we are tabling this project for discussion. We want to tackle some of these weak development challenges but also to create enabling environment where young people can contribute to the development of Kyrgyzstan. To reach the 2030 agenda we need to be ambitious and we are happy to have Russian Federation as a partner in this process. Thank you.

Presentation of the project by Mr. Mukash Kaldarov, UNDP Advisor on Social Cohesion (presentation attached)

#### **Q&A** session

Ms. Achikeeva Cholpon Chekirovna (Head of the Department for the Development of Local Self-Government, State Agency for Civil Service and Local Self-Government under the Cabinet of Ministers of the Kyrgyz Republic): "Thank you for the detailed presentation. I think it will be one of the successful projects. It is a pity that the geographical coverage of the municipalities is small, but what pleases is the creation of better conditions for the participation of young people in order to reduce the outflow of migration. This will definitely happen if they are trained in the basics of entrepreneurial activity, trained to work with local self-governments to develop socioeconomic development plans, and this will play a huge role in involving young people. It will also require legal advice to young people when building their own business, for example, when allocating a land plot, leasing and other operations, starting a business requires legal assistance. It is also important to develop marketing in parallel. Marketing also needs to be taught. It is also important to look at the best practice so that it can then be disseminated throughout Kyrgyzstan. I think the project will be successful. Our agency is ready to disseminate successful experience through the column of publications: "Successful experience of local self-government". Thank you!"

Ms. Erkina Urazbaeva: "Thank you, Ms. Cholpon Chekirovna for your valuable comments. They noted legal advice, marketing, collection and dissemination of successful practices. Thank you!"

Mr. Sultanbaev Ulan Sadyrbayevich (Head of Business Environment Policy Department, Ministry of Economy and Commerce of the Kyrgyz Republic): "Good afternoon, colleagues! We also propose to consider the issue of consulting and legal, training services in the field of financial literacy of young people. At the moment, the National Bank of the Kyrgyz Republic and other partners, authorized bodies are training the financial literacy of the population, why not include it as a subcomponent of the project."

Ms. Erkina Urazbayeva: "Thank you very much for your comment"

Mr. Daniyar Amanaliev (Ololo company): "Good afternoon, colleagues. I am a representing the private sector, the Ololo company. We have experience working with youth, including through collaboration with the UNDP peacebuilding team in designated locations. We did acceleration programs, we have experience in issuing grants. Thank you for continuing support to such projects, in particular, I would like to note the revolving mechanisms,

as the level of responsibility and effort increases versus one-way grant funding. I'm glad the locations are expanding. Kara-Balta, for example, recently hosted the first Hackathon, although Hackathons have never been held anywhere apart from Bishkek and Osh. There is a very active IT Academy in Kara-Balta, they work actively with young people. Youth participated in the Hackathon (from 14 to 25 years old) and there is already some kind of ground on which to work. It is better to rely on already existing mechanisms, which the more they live, the more they are trusted. It is also important to ensure the sustainability of initiatives. It is better to study previous experience and improve. For example, it is better than creating a new course to join those that already exist, such as the OSCE course (mini MBA). I am glad that this project is about the creative economy. Kyrgyzstan needs a creative economy and popularization of the creative economy so that young people and their parents have an understanding of what a creative economy is. I work mechanisms of competitions, olympiads, awards. Now we are discussing with the UNDP Accelerator Lab to hold a day of creativity on April 21, to hold exhibitions, and so on. If there is an opportunity to support activities on the day of creativity within the framework of this project, it would be useful."

Mr. Artem Romanov: In terms of the idea of using existing platforms, I propose to consider the possibility of using the platform "Russia - a country of opportunities", "Leaders of Russia", about 20 platforms are already functioning - in the field of digital education and other platforms in different segments of education. Perhaps it would be possible to explore the issues of interaction with such platforms, in particular, the allocation of quotas, materials. The feedback is quite positive from the participants and it would be possible to use such channels, as it is in harmony with the stated goals of the project.

**Ms. Monica Rijal:** "I want to pick up on the key issue of sustainability. The Deputy Minister also raised the issue of sustainability so this is something we really need to look at and build on existing courses and capacities exist. What happens when aid is ending. Have we left enough capacity when the support ends? I am happy to hear all participants raised this very important issue."

**Mr. Mukash Kaldarov**: "We agree and support all the raised proposals and comments. We also consider important the comment provided by Mr. Soyuzbek Nadyrbekovich on providing a legal framework to ensure greater sustainability of the supported and created mechanisms to support the entrepreneurial ecosystem."

## Conclusion and follow up

In general, the evaluation committee approves the project.

**Mr. Artem Romanov:** "Dear colleagues, today we had a lively discussion. This indicates that the project is in demand. There is no doubt that all the goals of the project will be achieved. The project itself is clear, there is a step-by-step implementation plan and there is great interest from national partners. I agree that in the composition which we gathered today, we can continue to monitor the progress of the project as an evaluation committee. Thanks a lot!"

**Ms. Monica Rijal:** "Discussion went so smoothly, comments were so constructive and it was so targeted to project. This is a signal of all good work done developing this project. I take this opportunity to thank all partners, private sector, participants of this meeting. The success of this project depends on partnerships. Thank you for the Russian Federation for standing partnership and confidence! And finally thank you to my team!
