By focusing on the promotion of Agenda 2030, the project has been designed according to the main standards related to the human rights-based approach, involving both national rights holders and duty bearers in the project's design and implementation. As human rights are at the heart of the Sustainable Development Goals, driven by progress on all SDGs, while the SDGs are also driven by advancements on human rights, the intervention, through strengthened national coordination and M&E system for the implementation of SDGs, SDG acceleration support, improved financing for SDGs achievement, as well as increased public awareness on the SDGs agenda, is expected to provide increased capacities and re-orient the Kyrgyz Republic towards the commitments to the leaving no one behind principle, the central, transformative promise of the 2030 Agenda for Sustainable Development. In this regard, the strategy is fully anchored on the National Sustainable Development Strategy 2018-2040 which will be the critical agenda for measuring progress towards national development targets, including equal access to health, education, rights to food, healthy nutritious food, decent work, culture, science, and civil integration.

The project supports the improvement of The annual Voluntary National Reviews (VNRs) including the gender policymaking, it will contribute to strengthening the National Statistical System for the improved collection and dissemination of SDG indicators, including gender. As a result, the gender-responsive policy based on gender analysis and evidence-based data enhances the policy implementation in line with the national gender agenda through effective implementation of the country's gender commitments. The project has gender marker 2, and it has the full potential to promote gender equality.

The project will not directly target environmental sustainability; the project intends to produce, among others, the annual Voluntary National Reviews (VNRs) process comprise the mechanisms through which progress against the SDGs is being measured at both national and international level. The Reviews are intended to track progress in implementing the 2030 Agenda, including the SDGs and targets, in all countries, in a manner that respects their universal and integrated nature and all dimensions of sustainable development. Among the principles guiding the Reviews, they must be substantive, and knowledge-based, with a particular focus on the poorest, most vulnerable and those furthest behind. It is crucial that the VNR drafting process is inclusive and grounded on the engagement with all stakeholders – part of the society. In particular, five thematic experts on Governance, Economy, Environment, Social, Monitoring, and Evaluation to be contracted by UNDP and to support the drafting of the review. UNDP will ensure the quality of the deliverables and their broader consultation, as well as will support making linkages between VNR and wider SDG work.




