






PROJECT BRIEF INFORMATION

The Kyrgyzstan Poverty and Environment Initiative aims to enhance the contribution of the environment to human well-being, pro-poor economic growth and achievement of the Millennium Development Goals. The intended outcome of the Kyrgyzstan PEI Phase 1 programme is the integration of **the poverty-environment nexus into national, sub-national, sectoral and UN, UNDP development policy processes and documents** - in order to improve environmental sustainability and ensure pro-poor economic growth.

Phase 1 of the PEI country programme for Kyrgyzstan includes three main outputs:

- **Output 1: P-E links integrated into processes of national and UN planning and programming;**
- **Output 2: Integration of P-E Linkages into sub-national (oblast), local planning and monitoring processes with relevant institutions piloted;**
- **Output 3: Awareness and capacity for P-E mainstreaming increased among various country**

Brief Description

The Kyrgyzstan Poverty and Environment Initiative aims to enhance the contribution of the environment to human well-being, pro-poor economic growth and achievement of the Millennium Development Goals. This Annual Work Plan covers Phase 1 closure period of the PEI country programme for Kyrgyzstan during the period of January-June 2014, and initiation period for Phase II during July-December 2014. The Project also intends to integrate a gender equality approach in P-E work by mainstreaming gender issues in all activities and addressing gender gaps in access to natural resource management and promoting of women's initiatives and leadership in P-E and sustainable development agenda development and implementation. In 2014, PEI will continue working on integration of poverty-environment nexus into national, sub-national, sectoral and UN, UNDP development policy processes and documents - in order to improve environmental sustainability and ensure pro-poor economic growth, with particular focus on following outputs:

- Output 1: P-E approaches and tools for integrated development policies, plans and coordination mechanisms applied;
- Output 2: Cross-sectoral budget and expenditure frameworks, coordination mechanisms, and environment-economic accounting systems institutionalised;
- Output 3: Pro-poor environmental outcomes are integrated into regional institutions and sustainable development processes.
