11.	DESCRIPTION OF MISSION ACHIEVEMENTS/TASKS COMPLETED:		

#### 12 June:

At the first day of the Forum, there were the following presentations and sessions for all group of Community conducted by trainers:

- About the Global Fund to Fight HIV, TB and Malaria. Role and functions of the CCM in cooperation with the GF and the Principal Recipient (PR)
- Legal acts and documents regulating CCM activities, regulations of the CCM (content, sections, key principles)
- Procedures for electing civil society representatives to the Committee on HIV and TB
- Implementation of CCM activities (formation of the composition, management of the CCM, holding meetings, making decisions)
- Procedures for electing civil society representatives to the Committee on HIV and TB
- Functional duties of the members of the Committee on HIV and TB from Civil Sector
- Discussion of the electoral strategy at the National Civil Society Forum

The participants from the Communities were very interested in these sessions as it was new for them and there were many clarification questions.

### 13 June:

At the second day of the Forum, there were two separate meetings, one – with SW community moderated by Shazhnaz Islamova and another – with Youth and Migrants Community moderated by Aibar Sultangaziev.

At the meeting with SW Community the following issues were discussed:

- Discussion and nomination of candidates from the community for the membership in Committee on HIV and TB.
- Involving people from the community in the leadership program
- Results of community lead monitoring
- What directions should be chosen for efficient work
- Situation with police raids
- Shakhnaz Islamova informed on activities conducted for addressing the issue with police raids: there were several letters from SWs to the Ministry of Internal Affairs, letter form Tais Plus to Prosecutor Office about illegal raids and violation, meeting and round tables

with the participation of representatives of Ministry of Internal Affairs, the working group was established within the Committee on HIV and TB, organization participates in preparing reports to CEDAW, OSCE, Ombudsmen, presents results of documented cases on human rights violation among SWs at different meetings, CCM, etc.

- It was discussed that SWs should write claims in case of violations, but nobody wants to do it as it could be even worse for them.
- There were groups discussions on recommendations on working with police and community.

At the meeting with Youth and Migrants Community the following issues were discussed:

- Changes in healthcare legislation, including HIV and TB
- Providing HIV services to migrants
- Services in the field of HIV and TB in the Kyrgyz Republic provided today
- Involvement of youth and migrants in processes related to HIV and TB
