The purpose of the project is to help the country cope with the growing number of infected frontline health workers, increasing intercommunity tensions at the border area in Fergana Valley, the rapid rise in unemployment, including due to returning labour migrants, and related risks including extreme poverty, social unrest, and stagnating or even back-sliding in SDG achievement caused by the COVID-19 crisis. To mitigate these effects the UNDP Kyrgyzstan aims to support effective, multi-sectoral, equitable, inclusive, human rights-focused crisis response and recovery to COVID-19.
