# **Association of Councils Enhanced Services Project (ACES)**

## 2013 QUARTER 1 REPORT

## 1. Description

### I. Executive summary

#### Progress (and alignment with National priorities):

3 year implementation program (IP3) and 10 year program of NCDD aimed to create local representatives through direct and indirect election of sub-national councils with anticipation of strengthening effective local service deliveries and development at localities. The political agenda committed to transfer applicable duty, function, personnel and finance to sub-national unified administrations, so, in the future sub-national councils can exercise their decision at their localities.

In alignment with national program (NCDD) and NLC/S five year strategy, a four year project (2012-2015) called Association of Councils Enhanced Services Project (ACES) was launched in June 2012 in order to strengthen the existing national league of communes and *sangkats* (NLC/S) and 24 provincial association of communes and *sangkats* (PAC/Ss) such as advocacy for local council interests, capacity development and service provision for local councils, supporting a development of league in the process of strengthening its internal systems and procedures and implementing a viable approach to increased financial sustainability, promotion of mutual learning among local councilors, promotion of gender equity in local politics, so, the final destination will be benefited to citizens and public. Specifically, the membership's expansion of current PAC/Ss and NLC/S was a first deliverable of ACES project. The League's expanding aims at incorporating the District/Municipal/Khan Councils to espouse by RGC policies and the key roles they play in service provision, downwards accountability, and bottom-up policy making processes.

In year 2011-2012, representatives of local councils (capital, provincial, district, municipal, commune and *sangkat* councils) discussed and agreed to form two ties of sub-national council associations—i) association of regional councils (capital and provinces) and associations of local councils (district, municipal, commune and *sangkat*), then, this agreement was officially endorsed by government (NCDD/MOI) on September 27, 2012.

The membership's expansion was discussed among concerning parties such as NLC/S, UNDP and NCDD-S by putting in two year plan (2013-2014), but, this plan has been not yet finalized in first quarter, 2013. With this regards, a decision from ACES board is strongly and urgently required at least 2013 annual work plan.

#### **Project Management, Coordination and Operations:**

- Operation, admin and financial arrangement at NLC/S's secretariat approved by UNDP and NLC/S in 2012. Currently, NLC/S has been applying and using NCDD-S rule while waiting for a new SOP to be developed by international consultant.
- Temporary manual of financial and account system developed and introduced to PAC/S. This manual will gradually revise and justify, then fully apply in year 2015.
- Three positions under NLC/S contract (ACES's financial support) such as institutional building officer (IBO), human resource officer (HRO) and finance officer (FO) are under

- recruitment process--IBO candidates conducted a written test and interview will be conducted by the end of March or early April). HRO and FO positions have shortlisted. However, HRO, FO and 12 provincial back stopper positions are also pending and waiting until 2013 AWPB finalized by UNDP and NLC/S management or ACES project board.
- Two year work plan has been discussing, revising, modifying and justifying in according with comments and suggestions from NLC/S, UNDP and NCDD-S. The plan is still not yet finalized by ACES project board.

# II. Implementation progress

# PROGRESS TOWARDS PROJECT OUTPUTS:

Due to 2013 annual work plan has not yet finalized by project board. Therefore, the progress will report against first quarterly work plan as an agreement between UNDP and NLC/S.
