2014 QUARTER 2 REPORT

I. Executive summary

ACES project – "Associations of Councils Enhanced Services" – is aimed at turning the National League of Communes and Sangkats (the League) into an effective representative of local voices for democratic development. The project builds on the previous EU-UNDP support project for Democratic and Decentralized Local Governance (DDLG, 2006-2011) which enabled the establishment and the development of the League, the only Local Government Association in Cambodia. As the sole representative of Local Council interests, the League is critical to the successful outcome of the country's decentralization process participating in policy reform and project implementation.

The ACES project is aligned to the League's 2nd strategic plan 2011-2015 and the Royal Government of Cambodia's (RGC) decentralization policies, in particular the National Programme of Sub-National Democratic Development (NP-SNDD) 2010-2019 and its first Implementation Plan (IP3) 2011-2013.

The project substantially contributes to;

UNDAF" **Outcome 4:** By 2015, national and sub-national institutions are more accountable and responsive to the needs and rights of all people living in Cambodia and leading to increased participation in democratic decision making".

UNDP's CPAP outcome" **Outcome 4:** By 2015, sub-national Administrations have capacity to take over increased functions"

UNDP's CPAP output" *Output 4.3:* Local Government Associations are better able to advocate for their members and provide them services"

In response to CPAP outcome and output above, during this second quarter of year 2014, the Project Team has tried hard to focus on the expansion of membership of the Provincial Association (13 provinces) to include the Councils of Districts, Municipalities and Khans to the Provincial Associations and the establishment of the National League of Local Councils (NLC) as recommended by Project Board's statement on 12 March 2014. On the other hand, POMM and Structure of Joint-Secretariat of Regional and Local Association drafted and reviewed.

As the result for this quarter, 13 provinces had successfully organized its provincial congresses to expand the membership to include the councils of Districts, Municipalities and Khans to its Provincial Associations (Local Association). The attendants for these congresses totaled 2497 (345 females).

The final draft of Practical Operational Management Manual (POMM) for the National League and both Associations (Regional and Local) submitted and accepted and translated into Khmer version and subject to final review by all relevant staff and leaders. The workshop will be organized to approve POMM in quarter 3 or 4, 2014.

The structure of joint-secretariat presented in the National Task Force Meeting held on 19-20 June 2014 in Siem Reap with participants around 30 (5 females) to get agreement prior to organizing the workshop to approve it officially in quarter 3 or 4, 2014.

However, there will have some issues and challenges encountered during this quarter such as staff resignation (Communication Officer), the election of the councils of Capital, Province, District and Khan on 18 May 2014 and the separation of Tbong Khmom from Kompong Cham province affected the time-frame and budget of work plan. However, due to the intervention of relevant stakeholders and the commitment of NLC and its staff (ACES team), these issues and challenges successfully solved.

The last but not least, the follow-up and backstop of Provincial Associations in implementing the accounting system to manage their membership fee and donors fund is crucial. Until now, approximately 50% of these associations can manage their funds and produced the financial report accuracy.

II. Implementation progress

DELIVERABLE01: The consultation processes required for the expansion of the League's membership with District, Municipal and Khan Councils have been designed, endorsed by the RGC, and implemented.

National Task Force meeting (NTF) organized in Siem Reap (26-27 March 2014), in Phnom Penh (18-19 April 2014) and in Siem Reap again (19-20 June 2014) to finalize the statute and internal rule for expansion to include DMKs and the new National League of Local Councils (NLC) and set the deadline for organizing the congress to establish the National League of Local Councils (NLC). The meeting presided over by H.E Nam Tom, chief of NTF and chief of Provincial Councils, attended by all NTF members and concerned stakeholders i.e. NCDDS, MoI, UNDP/ACES and NLCS.

13 provinces had successfully organized its provincial congresses started from 10th- 26th April 2014 to expand the membership to include the councils of Districts, Municipalities and Khans to its Provincial Associations (Local Association) namely Kompot, Kep, Kompong Speu, Batambang, Stoeng Treng, Prey Veng, Banteay Meanchey, Kompong Som, Siem Reap, Svay Rieng, Koh Kong, Odor Meanchey and Mondulkiri. The attendants for these congresses totaled 2497 (345 females). However, Kompong Cham and Tbong Khmom need to be re-organized the congresses to separate into two Associations which will be held on 15 July 2014 by using their membership fees.

DELIVERABLE02: The League and its Provincial Associations have revised, improved and put into practice solid internal systems and procedures.

The final draft of Practical Operational Management Manual (POMM) for the National League and both Associations (Regional and Local) submitted, accepted and translated into Khmer version and subject to final review by all relevant staff and leaders. The workshop will be organized to approve POMM in quarter 3 or 4, 2014.

The structure of joint-secretariat presented in the National Task Force Meeting held on 19-20 June 2014 in Siem Reap with participants around 25 (5 females) to get agreement prior to organizing the workshop to approve it officially in quarter 3 or 4, 2014.

Long and short distant coaching on financial management and accounting system conducted to the secretaries and assistants of Provincial Associations. As the result, they can operate this system effectively to manage their membership fees and donors support fund.

DELIVERABLE07: The interests of Local Councils and citizens have been promoted employing constructive methods for advocacy of clearly defined needs and demands.

The National League's Newsletter produces late this year due to the resignation of the Communication Officer in March 2014. The New Communication Officer was on board in 1st June 2014. The newsletter will produce its first semester by end of June 2014.

DELIVERABLE10: The members of the League have endorsed and implemented standards for public ethics in local government.

The Code of Conduct (CoC) for both Regional and Local Association finalized in August year 2013 after that both Regional and Local Associations drafted for their own Association with the assistance from ACES technical team. The Code of Conduct (CoC) for both Associations will disseminate officially in quarter 3 or 4, 2014.

Capacity Development:

In year 2014, Capacity Development to NLCS and PACS remains the project's outstanding attention through conducting trainings, workshop, meetings, exposure visit and coaching. This year 2014, training on leadership, facilitation skills and financial management for PACS leaders, secretaries and assistants conducted in Svay Rieng on 10-13 February 2014. During these sessions, most participants are reflected and aware of their leadership in response to the needs of their members and citizens at their localities.

Gender:

The national league of Communes and Sangkats (NLCS), at the National Task Force meeting on 29 August 2013, encouraged the participation of women in politics by enshrining and enforcing the statutes of Local and Regional associations to promote the women for their participation in all activities conducted by NLCS and Associations. In year 2014, League's Women and Children Committee and M&E Officer had attended the training on the promotion of positive views of male in support of women's roles in politics held on 25-26 February 2014. With support from EU and UNDP, dissemination workshop will be conducted to all women councillors and the Women Committee to strengthen and disseminate the roles and responsibilities.

Lessons learnt:

The methodologies for the expansion of membership of PACS to include District, Municipality and Khan (DMK) conducted to 11 provinces in year 2013 will continue for the rest of the provinces this year as it was cost-effective and expeditious.

In organizing the provincial congresses for the rest of 13 provinces, before that a reflection workshop organized in Kompong Som to reflect the 11 provinces expansion strategies in relation to Advance Mission Team (AMT), DSA and travel costs clarification, the threshold of budget per province and its flexibility and membership fee contribution to the congress. All these issues had already been clarified prior to the congresses. As the result, the congresses went smoothly as plan.
