Environmental challenges are profound and pervasive threats that affect many aspects of human health and well-being. For instance, air pollution, one of the biggest environmental issues, has the biggest impact, accounting for two-thirds of deaths globally. Likewise, environmental challenges threaten fundamental human rights, such as the right to life, health, well-being, safe works, as well as protections of children and the most vulnerable. The goal of the project 'Sustainable Environmental Civil Society in Kosovo' is to strengthen the specialization and capacities of Environmental Civil Society Organizations in Kosovo in order for them to articulate their needs and keep up with international standards, including principles, conventions as well as funding mechanism, particularly in regard to the Global Environmental Facility-Small Grants Programme. In doing so, the project will ultimately contribute to the achievement of the Sustainable Development Goals.

The project will put emphasis on protection of the respect for their rights, and gender equality. In the initial phase of the project, a gender analysis will be performed.
