### QUESTION 1: How Does the Project Integrate the Overarching Principles in order to Strengthen Social and Environmental Sustainability?

#### Briefly describe in the space below how the Project mainstreams the human-rights based approach

The 18-month joint project aims to provide a space for youth from all backgrounds, with a strong emphasis on young women, in the selected localities in Kosovo to work together to address shared challenges and become more active changemakers that will catalyze peacebuilding efforts in Kosovo. The project theory of change is that if young women and men can be brought together to work jointly on issues of shared concern and implement their efforts in cooperation with the institutions of service delivery, and if their capacity and influence to be more active changemakers, in particular that of young women, can be enhanced, then persistent prejudices between communities and mistrust between communities and the institutions will be challenged and diminished by empirical observation, and those young women and men will become effective advocates for a shared future.

Thus, the outcome of this project is expected to be that the influence of conflict narratives and prejudice has decreased through improved social cohesion resulting from local populations working together and with local institutions on contemporary issues of shared interest to jointly develop solutions for a common future.

Such approach employs a heavy focus on promoting of inter-community trust, social inclusion, peace and trust building within communities, between communities, as well as between communities and public service providers. The project offers space for young women and men to seize their potential through working together across communities, volunteering, employment and skills development opportunities, as well as direct measures of women's empowerment. The project also supports public institutions, such as employment offices, to become more effective and responsive to the needs of their communities, streamlining human rights-based approach to service delivery.

#### Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment

The project streamlines women's empowerment and gender equality across its components. The project will promote equal participation of young women and men and will have specific activities dedicated to women's empowerment. In Outputs 1.1. and 1.2., the project sets targets to reach 45-50% of women among its beneficiaries. Moreover, the entire Output 1.3. is dedicated to women's empowerment. In particular, the young women beneficiaries will be supported to develop practical project initiatives in service of the

implementation of UNSCR 1325 in their home communities. Across the project, 70% of the budget is dedicated to women's empowerment. The project will monitor very closely impact of its activities, and will promote women's voices in its implementation, as well as further advocacy and awareness raising campaigns.

Briefly describe in the space below how the Project mainstreams environmental sustainability

The project does not foresee any negative environmental impact, as it provides individual direct job placements, volunteering opportunities, skills and competency development, women's empowerment. Under the Self-Employment Programme which aims to reach 30 people, the establishment of micro-level start-ups does not foresee any significant impact on environmental sustainability, and environmentally-conscious start-up ideas will be promoted.
