The project is based on human rights approach. The project's *Theory of Change* is firmly focused on the livelihood recovery needs of communities in Libya that have been beneficiaries of UNDP's stabilization and resiliency efforts. START aims to leverage expertise, knowledge, and partnerships gained through engagement in communities across Libya over several years to improve quality of life through increased livelihoods opportunities.

##### **Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment**

Women and girls were the most vulnerable categories of people, in the conflict in Libya. Therefore, special measures to empower women and girls to reduce their victimization and ensure gender equality, will be adopted by the Project START, recognizing also that women in Libya are not just victims, but have an active role as bread winners, volunteers, recovery and reconstruction workers, and advocates for peace.

Furthermore, "Gender Analyses" were ensured in the project design and in all its implementation phases, "Gender Mainstreaming" is not only reflected in the projects' activities but also included in the reporting (disaggregated data), monitoring and evaluation of the project impacts and results.

START project is aiming to achieve at least 30% women participation. For examples: activities are geared towards women's inclusion and participation of the project activities such as cash-for-work modality, whereby women will be selected directly to participate and earn an income; or small business grants/asset grants for female headed households or business creation support women etc..




The project will not have any impact on environmental sustainability as the project has no rehabilitation works or procurement component. The project START is mainly to strengthen local resilience and stabilization efforts.
