# LKA 2330, 11/0067, Addendum No. 1 to Agreement between the Norwegian Ministry of Foreign Affairs and United Nations Development Programme regarding Integrating Gender Support to the UN Country Team Sri Lanka 

WHEREAS the Norwegian Ministry of Foreign Affairs (MFA) and United Nations Development Programem (UNDP) have entered into an Agreement dated 2 October 2012 on Integrating Gender Support in the UN Country Team (the Agreement),

WHEREAS UNDP in a letter dated 20 June 2013 has requested MFA for continued support to Integrating Gender Support in the UN Country Team until 30 June 2014 and MFA has decided to comply with the request,

WHEREAS MFA and UNDP have agreed on amending the Agreement,

NOW THEREFORE MFA and UNDP have reached the following understanding which shall constitute Addendum No. 1 to, and an integral part of, the Agreement:

## Article I

The Planned Period of the Project shall hereby be extended until 30 June 2014.

## Article II

The scope of the Project under the Agreement shall include the following components as detailed in the Project Proposal 'Integrating Gender Support to the UN Country Team' dated 25 July 2013 in addition to the components stated in Article I of the Agreement:

- Lead and Support UNDAF Engagement on Gender Issues
- Communication and Advocacy on Gender Issues,
- Identification and Support of Research Initiatives


## Article III

MFA shall, subject to Parliamentary appropriations and the terms and procedures of the Agreement and this Addendum, provide an addition to the Grant not exceeding NOK 438234 (Norwegian Kroner four hundred thirty eight thousand two hundred thirty four) in the Planned Period.

Disbursements shall be made upon written requests as stipulated in the Agreement.
