A. **SUMMARY OF ACTIVITIES**

Title: Comprehensive Analysis of Mental Health and Psychosocial

Support Services in Sri Lanka (the "Activities")

Purpose Mental health and psychosocial support (MHPSS) is of

significant importance to Sri Lanka, as the country's civil was affected individuals and communities for almost 3 decades. Research conducted in the post-war context, since 2009, has provided evidence of a range of complex and inter-related issues still affecting communities and survivors. In addition to directly causing psychological suffering, war and its aftermath has also damaged or destroyed many social supports and material resources that affected people's need for coping and recovery. Furthermore, recent studies carried out by The Asia Foundation and The Good Practice Group indicate of a decline in the civil society MHPSS service provision over the years straining the accessibility and quality of services available to affected populations. The recent government- appointed Consultation Task Force on Reconciliation Mechanisms (CTF) report highlights serious gaps in ensuring appropriate MHPSS services are available for survivors and communities. The report also highlights the vital role of civil society organizations in providing non-partisan, neutral support in the post-war context. As supported by international empirical evidence, integration of MHPSS within transitional justice and reconciliation processes, aimed at supporting individual and collective recovery, is critical to restoring day-to-day

functioning and wellbeing on both levels.

As such, there is a need for MHPSS services in Sri Lanka to improve the coordination among partners, avoided siloed and repetitive interventions and facilitate platforms that enable sharing of lessons learnt and good practices. The availability of such country specific information will provide a solid foundation to transitional justice and reconciliation mechanisms such as the recently established Office on Missing Persons (OMP) in setting up its psychosocial support services.

In this regard, this project aims to provide a more comprehensive and updated view of the existing MHPSS services and gaps to better inform future interventions while building the district based capacity to maintain better MHPSS related information systems, better coordination among partners and pilot interventions capable of strengthening community based capacity for better problem identification and resolution. In addition to the OMP, outputs of this project will better inform the work of the Secretariat for Coordinating Reconciliation Mechanisms (SCRM) and the Ministry of National Integration and Reconciliation. In recognition of the significance of the impact that can be achieved through the project, WHO Sri Lanka, will bring in expertise; locally, regionally and globally so support the programmes.

The project will focus on primary data collection, assimilation, analysis and visualizations in addition to the support for capacity building training for district level counterparts and dissemination efforts at the district, provincial and central levels.

- 2. Final Certified Financial Status (FCFS) by 31 October 2019

E. <u>CONTRIBUTIONS</u>

The total amounts paid by the Contributing Agency shall match the total budget amount. For activities less than one year in duration, the Contribution will be paid to the Recipient Agency prior to the commencement of Activities. For multi-year activities, the Contribution will be paid in instalments according to the following schedule.

H. AMENDMENTS

The present Agreement, including its Annex(es), may be modified or amended only by written agreement between the two Agencies.

I. COMPLETION OF THE ACTIVITIES

The Recipient Agency will notify the Contributing Agency when all Activities have been completed.

The Recipient Agency will continue to hold any part of the Contribution that is unutilized at completion of the Activities until all commitments and liabilities incurred in the carrying out of the Activities have been satisfied and all arrangements associated with the Activities have been brought to an orderly conclusion.

J. TERMINATION OF THIS AGREEMENT

This Agreement will terminate upon satisfaction of all commitments and liabilities incurred in carrying out the Activities and the orderly conclusion of all arrangements associated with the Activities.

This Agreement may be terminated by either Agency at any time by written notice to the other. Termination will be effective thirty (30) days after receipt of the notice. In the event of termination under this paragraph, the two agencies will cooperate to ensure completion of the Activities, satisfaction of all commitments and liabilities, and the orderly conclusion of all arrangements associated with the Activities.

K. REFUNDS OF UNSPENT BALANCES

OPTIONS:

1. Upon termination of this Agreement and following the submission of the final financial report, any unspent balance of the Contribution (where the unspent funds exceed US\$1,000) will be returned to the Contributing Agency, unless otherwise agreed in writing by the two Agencies.

OR

2. Upon termination of this Agreement and following the submission of the final financial report, any unspent balance from the Contribution will be returned to the Contributing Agency, unless otherwise agreed in writing by the two Agencies.

L. <u>SETTLEMENT OF DISPUTES</u>

The two Agencies will use their best efforts to promptly settle through direct negotiations any dispute, controversy or claim arising out of or in connection with this Agreement or any breach thereof. Any such dispute, controversy or claim which is not settled within sixty (60) days from the date either party has notified the other party of the nature of the dispute, controversy or claim and of the measures which should be taken to rectify it, will be resolved through consultation between the Executive Heads of each of the Agencies.

ENTRY INTO FORCE AND VALIDITY M.

This Agreement will enter into force upon its signature by the authorized representatives of the Parties and remain in force until terminated in accordance with Section J above.
