

**AMENDMENT TO THE CONTRACT BETWEEN**  
**THE OFFICE OF THE HIGH COMMISSIONER FOR HUMAN RIGHTS (OHCHR)**  
**AND**  
**UNITED NATIONS DEVELOPMENT PROGRAMME MOROCCO (UNDP)**

Reference is made to the Cost Sharing Agreement (hereinafter "Agreement") "AGREEMENT BETWEEN THE OFFICE OF THE UNITED NATIONS HIGH COMMISSIONER FOR HUMAN RIGHTS (OHCHR) AND UNDP-COUNTRY OFFICE IN MOROCCO (UNDP)" dated 26<sup>th</sup> of November 2013 signed between the UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP), and the OHCHR, with respect to the Project 00087007 Supporting the Inter-ministerial Delegation for Human Rights (DIDH) in the Integration of Human Rights in public policies, and as per Article F – Final provisions of the Agreement, any modification to this Agreement shall be made in writing between both parties and duly signed by the authorized representatives of the Donor and UNDP.

Therefore Parties hereby agree on the following;

WHEREAS the donor and UNDP now wish to amend the said Agreement in order to increase OHCHR's overall contribution amount to the project;

WHEREAS such Amendment will result in an increase of US\$ 50,578 making this amended Agreement total of US\$120,578 for the period 2013-2014.

NOW THEREFORE, the relevant Agreement provisions indicated below are hereby amended to read as follows:

**D. PAYMENT INSTRUCTIONS**

OHCHR transferred to UNDP-Morocco a total amount of US\$ 70,000 (seventy thousand US dollars) representing the OHCHR contribution share towards the UNDP project Atlas no. 00087007 as per the project document signed by OHCHR on 25 September 2013. This amount served to fund 2013 activities 1.2.1 (organisation of seminar on preparation of UPR mid-term report) and 1.2.3 (organisation of one national consultation and three regional consultations to prepare the UPR mid-term report). In 2014, the OHCHR contribution will amount to US\$50,578, which includes UNDP support services fee estimated at USD 3,308.84 (7% of total OHCHR contribution). These funds will contribute to support project activities as described in the project document and programme of work under activities 1.1.3 (organisation of a workshop for parliamentarians on human rights standards and norms), and 2.3.1 (organisation of a training of trainers to develop human rights indicators) of the UNDG-HRM project, see Annex I. The

allocation of the funds described above shall not be modified except with OHCHR's express and written agreement in advance.

Payments will be made according to the following schedule:

At the completion of each activity, a comprehensive final narrative report and certified financial statement will be provided to OHCHR. All funds that UNDP does not use in the implementation of activities as described above shall be returned to OHCHR, unless otherwise agreed in writing by the parties.

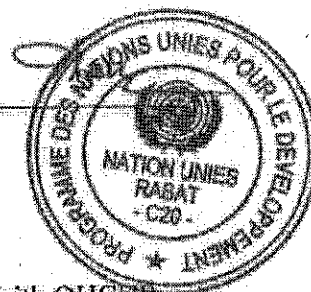
