A. MICRO-CAPITAL GRANT AGREEMENT

MICRO-CAPITAL GRANT AGREEMENT BETWEEN THE UNDP AND THE CITIZENS ASSOCIATION (ZDRUZENIE NA GRAGJANI) SMART-UP – SOCIAL INNOVATION LAB FOR THE PROVISION OF GRANT FUNDS

Micro-Capital Agreement (hereinafter referred to as the "Agreement") made between the UNDP as Implementing Partner and the Recipient Institution, the Citizens Association Smart Up – Social Innovation Lab (hereinafter referred to as "Smart-up")

WHEREAS the United Nations Development Programme ("UNDP") manages the project defined in project document 00109163- RESILIENT SKOPJE: SCALING-UP FOR SUSTAINABILITY, INNOVATION AND CLIMATE CHANGE (hereinafter referred to as "the Project"), with the financial support of the City of Skopje and UNDP.

WHEREAS UNDP desires to provide funding to Smart-Up in the context of the Project and on the terms and conditions hereinafter set forth, and

WHEREAS Smart-Up is ready and willing to accept such funds from UNDP for the above-mentioned activities on the said terms and conditions.

NOW, therefore, the parties hereto agree as follows:

I. Responsibilities of the RECIPIENT INSTITUTION

- 1.1 The Smart Up agrees to: 1) Undertake the activities described in its **Workplan** and **Budget** (attached), and updates related to the subsequent release of funds in **tranches**; 2) Provide quarterly reports to the project Board; and 3) Provide Annual Audited Statement [Income Statement and Balance Sheets]. Funds provided pursuant to this Agreement shall be used for purposes related to producing results specified in its annual performance targets [Section C].
- 1.2 The Smart Up agrees to reach the performance targets contained in Section C. If the Smart Up fails to meet its responsibilities outlined in article 1.1 or to attain at least 70% of any one performance target, then this will be considered grounds for the Project Board to suspend any further micro-capital grant support. The suspension shall remain in effect until Smart Up has achieved the target.
- 1.3 Smart-Up agrees to inform UNDP about any problems it may face in attaining the objectives agreed upon.

II. <u>Duration</u>

2.1 This Agreement will come into effect on 6 **September 2018** and shall expire on **28 February 2019**, covering the anticipated term of the project. It can be extended, if necessary by exchange of letters, noting the new expiration date.

III. Payments

3.1 UNDP shall provide funds to Smart-Up in the amount up to 29,995 USD in MKD according to the UN Exchange Rate effective on the day the transfer is made, and to the schedule of the project budget set out below. Payments are subject to Smart-Up meeting the outputs as specified below and providing respective narrative and financial reports, certifying that at least 70% of the previous tranche(s) has been expended.

3.3 The amount of payment of such funds is not subject to any adjustment or revision because of price or currency fluctuations or the actual costs incurred by Smart-Up in the performance of the activities under this Agreement.

IV. Records, Information and Reports

- 4.1 Smart-Up shall maintain clear, accurate and complete records in respect of the funds received under this Agreement.
- 4.2 Smart-Up shall furnish, compile and make available at all times to UNDP any records or information, oral or written, which UNDP may reasonably request in respect of the funds received by Smart-Up.
- 4.3 Within sixty days after completion of project activities, Smart-Up shall provide UNDP with a final report with respect to all expenditures made from such funds (including salaries, travel and supplies) and indicating the progress made toward the goals of the activities undertaken, utilizing the reporting format contained in Annex I.

V. General Provisions

- 5.1 This Agreement and the Annexes attached hereto shall form the entire Agreement between Smart-Up and UNDP, superseding the contents of any other negotiations and/or agreements, whether oral or in writing, pertaining to the subject of this Agreement.
- 5.2 Smart-Up shall carry out all activities described in its proposal with due diligence and efficiency. Subject to the express terms of this Agreement, it is understood that Smart-Up shall have exclusive control over the administration and implementation of the activities referred to above in paragraph 1.1 and that UNDP shall not interfere in the exercise of such control. However, both the qualities of work and the progress being made toward successfully achieving the goals of such activities shall be subject to review by UNDP. If at any time UNDP is not satisfied with the quality of work or the progress being made toward achieving such goals, UNDP may: (i) withhold payment of funds until in its opinion the situation has been corrected; or (ii) declare this Agreement terminated by written notice to Smart-Up as described in paragraph 5.7 below; and/or seek any other remedy as may be necessary. UNDP's determination as to the quality of work being performed and the progress being made toward such goals shall be final and shall be binding and conclusive upon Smart-Up insofar as further payments are concerned.
- 5.3 UNDP undertakes no responsibilities in respect of life, health, accident, travel or any other insurance coverage for any person which may be necessary or desirable for the purpose of this Agreement or for any personnel undertaking activities under this Agreement. Such responsibilities shall be borne by Smart-Up.
- 5.4 The rights and obligations of Smart-Up are limited to the terms and conditions of this Agreement. Accordingly, Smart-Up and personnel performing services on its behalf shall not be entitled to any benefit, payment, compensation or entitlement except as expressly provided in this Agreement.
- 5.5 Smart-Up shall be solely liable for claims by third parties arising from Smart-Up's acts or omissions in the course of performing this Agreement and under no circumstances shall UNDP be held liable for such claims by third parties.
- 5.6 Assets (Equipment) supplied by UNDP funds to Smart-Up shall be the property of UNDP until the end of the project, at which time UNDP shall determine the best use of these assets. In cases where Smart-Up has met its responsibilities under this agreement, and handover of the asset would contribute to the sustainability of activities, UNDP would normally handover these assets to Smart-Up. The assets shall be used for the purpose indicated in the Proposal throughout the period of this Agreement.
- 5.7 This Agreement may be terminated by either party before completion of the Agreement by giving thirty (30) days written notice to the other party, and Smart-Up shall promptly return any unutilized funds to UNDP as per paragraph 5.6 above.
- 5.8 Smart-Up acknowledges that UNDP and its representatives have made no actual or implied promise of funding except for the amounts specified by this particular tranches Agreement. Although project related documents may indicate a total amount of funds that could be available for Smart-Up, actual disbursements will be based upon Smart-Up's meeting performance targets. If any of the funds are returned to UNDP or if this Agreement is rescinded, Smart-Up acknowledges that UNDP will have no further obligation to Smart-Up as a result of such return or rescission.
- 5.9 No modification of or change to this Agreement, waiver of any of its provisions or additional contractual provisions shall be valid or enforceable unless previously approved in writing by the parties to this Agreement or their duly authorized representatives in the form of an amendment to this Agreement duly signed by the parties hereto.
- 5.10 Any controversy or claim arising out of, or in accordance with this Agreement or any breach thereof, shall unless it is settled by direct negotiation, be settled in accordance with the UNCITRAL Arbitration Rules as at present in force. Where, in the course of such direct negotiation referred to above,

the parties wish to seek an amicable settlement of such dispute, controversy or claim by conciliation, the conciliation shall take place in accordance with the UNCITRAL Conciliation Rules as at present in force.

The parties shall be bound by any arbitration award rendered as a result of such arbitration as the final adjudication of any such controversy or claim.

5.11 Nothing in or relating to this Agreement shall be deemed a waiver of any privileges and immunities of the United Nations, or UNDP.
