QUESTION 1: How Does the Project Integrate the Overarching Principles in order to Strengthen Social and Environmental Sustainability?

Briefly describe in the space below how the Project mainstreams the human-rights based approach

The United Nations system has already been deeply engaged in supporting the humanitarian response, in an effort to provide food and shelter and protect the human rights of thousands of people transiting through the country *en route* to Western Europe. The United Nations Development Programme (UNDP) is working to complement humanitarian aid efforts by supporting national and local stakeholders to develop and implement long-term sustainable solutions to the current crisis. The initial focus has been on helping partner municipalities respond to the crisis, most visibly in the provision of waste-management equipment. UNDP's longer-term objective is to strengthen the capacities of the host communities to deliver public services to refugees and residents alike, while ensuring that these efforts are sustainable over the longer term and also in line with human rights and gender equality commitments.

Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment

Although there are no specific activities addressing gender issues, one of the aims of the project is to provide needs assessment based on a methodology agreed with the municipalities that would give an overview of the needs (including gender-differentiated needs) of the most vulnerable groups and categories of both migrants/refugees and host communities. The planned efforts will take into account the needs of the most vulnerable, including victims of SGBV.

Briefly describe in the space below how the Project mainstreams environmental sustainability

The aforementioned assessment will also focus on the issues of ecological/environmental sustainability and the burden on water, sewage and other public utilities, as well as the particular impact on the migrant communities transiting and/or staying. In addition to the assessment, the project also involves construction of a landfill in one of the municipalities, which was the gravely affected by the migrant crisis. Prior the construction of the landfill, Environment




Impact Assessment (EIA), will be carried out to assess if the construction of the landfill could cause negative environmental effects, and how these effects could be mitigated.
