Opening

The meeting was opened with remarks by the co-chairs, Dr. Nyi Nyi Kyaw, the DG of the Forest Department and Mr. Peter Batchelor, the UNDP Country Director.

In his opening, Dr Nyi Nyi Kyaw reviewed progress made during 2017, noting that there is now a draft National REDD+ Strategy, the initial FREL was already submitted to UNFCCC through UNFCCC focal person on 8th of January 2018, and a National Forest Inventory design document is being prepared. He noted that the process to develop a SIS has begun and called for acceleration of this process. The National REDD+ Taskforce is now fully active, and the preparation of a GCF proposal is important as it represents a stepping-stone towards Phase 3 and results-based payments.

Mr. Peter Batchelor mentioned that the UNDP Country Office had undergone some profound changes, with the creation of a Sustainable and Inclusive Growth programme, under which the UNDP component of the UN-REDD Programme falls. He commented that the GCF proposal is opening some interesting opportunities for collaboration with the private sector, and that the up-coming meeting of the ASEAN Institute for Green Economy (AIGE) would also open doors to broader engagement.

The co-chairs offered other members of the PEB the opportunity to make opening remarks.

U Hla Maung Thein noted that REDD+ is an instrument to implement Myanmar's Nationally-Determined Contribution, and a very important one since forests are the largest contributor to GHG emissions. He urged that the GCF proposal be developed as quickly as possible.

Ms. Xiaojie Fan mentioned that an FAO TCP project was being launched the next day and expressed FAO interest in working on the GCF proposal.

Decision PEB 3/5 provided for a report to each PEB meeting of the activities of the National REDD+ Taskforce. The summary was provided by Dr. Thaung Naing Oo, Secretary to the Taskforce.

The Taskforce held its 2nd meeting on 15 December 2017. In addition to presentations by various REDD+ related projects, the Taskforce discussed how it can effectively deliver its mandate. It reached several decisions on this matter, two of which related to UN-REDD. These were:

- The TF requests the UN-REDD Programme to compile a database of "REDD+ related programmes for review and approval at next TF meeting; and
- The TF has requested the UN-REDD Programme to prepare a detailed analysis of costs and benefits of mixing forest carbon schemes in Myanmar (Decision 2/2). This should be presented to the 3rd meeting of the TF

The Taskforce decided that it would meet at least every 3 months during 2018, meaning its next meeting will be in March.

Discussion

The PEB agreed to the two requests from the Taskforce for assistance from UN-REDD (**Decision** 4/4).

Session 1: Updates

a) State of advance UN-REDD Programme in Myanmar, development towards major targets for 2017

Dr Thaung Naing Oo, the National Programme Director of UN-REDD Programme presented the progress and achievements of the programme implementation during 2017. He focused only on those outputs and activities where some delays had been encountered.

No delays had been encountered in Outcome 1. In Outcome 2, development of a Capacity building plan and Competency framework, which was encountering severe delays at the time of PEB-3, had now overcome the barriers, due to corrective action recommended by the PEB. Provision of training had encountered slight delays due to a delay in contracting the service provider.

In Outcome 3, delays were encountered in developing the clarification of safeguards and in the PLR/GRM analysis, due to the contracting process of consultants and service providers. In Outcome 4, slight delays were encountered in the land cover classification and NFI design, due to technical problems. In Outcome 5, the development of a REDD + investment plan was delayed due to delays in consultant recruitment.

Overall delivery against budget was 104%, due to a very high delivery for UNEP, accounted for by expenditures originally planned for 2016 being completed in 2017 (FAO 95%, UNDP 99%, and UNEP 146%).

Discussion

The PEB discussed the delays and overall progress. The communications work was highlighted, and the need to ensure that the language was appropriate to the audience noted, together with a request to focus on parliamentarians in 2018. It was also noted that the draft National REDD+ Strategy should be presented to the Land Use Council (**Decision 4/13**). It was noted that there was an arithmetical error in the figures for FAO expenditure provided in the presentation. The corrected figures are:

b) Fulfillment of actions from meetings minutes of last PEB meeting in July 2017

Daw Khin Hnin Myint, Programme Coordinator of UN-REDD Programme presented the actions and follow-up activities taken on the 3rd PEB meeting decisions. Action had been taken on all decisions. For many of the decision, further information was provided in subsequent agenda items.

c) Proposed revisions to UN-REDD Results Framework

Mr. Tim Boyle, interim CTA, presented the revised programme results framework prepared by the Regional team and PMU, responding to PEB Decision 3/3, has revised. Attention was paid to the desire to avoid having to refer back to the UN-REDD Executive Board for approvals of substantive changes at Outcome or Output level. The proposed wording changes at Outcome and Output level were mainly to ensure that the wording corresponded with the result-level – for example, that wording of an Output did not represent an activity. Many more changes were made to the wording of indicators to strengthen them.

Discussion

The PEB agreed that none of the wording changes at Outcome or Output level represented substantive changes, and requested that the PMU continue to report on the need for further changes. The PEB approved the changes, subject to one modification: Output 5.1 should be "National REDD+ Strategy finalized", rather than simply "National REDD+ Strategy" (**Decision 4/3**).

d) M&E plan and results for Year 1

Responding to PEB Decision 3/3, an M&E plan has been developed. Daw Khin Hnin Myint presented the results from year 1 indicators. Year 1 targets were met or exceeded for 8 indicators; targets were nearly met for 4 indicators, and not met for two indicators, both under Output 2.1, relating to access to, and availability of information.

Discussion

The PEB noted the progress made and the shortcomings in meeting targets under Output 2.1. The PEB instructed the PMU to emphasize work on communications to ensure Output 2 indicators are met for year 2 (**Decision 4/8**). The PEB approved the M&E plan (**Decision 4/2**).

e) Report on experiences under PEB Decision 3/10 (ref. PEB Decision 3/11)

PEB Decision 3/10 delegated authority to the NPD to approve budget changes across outputs or budget lines within outputs, within stated limits. Decision 3/11 instructed the PMU to prepare a report on experiences in implementing Decision 3/10. Dr. Thaung Naing Oo presented the report, noting that while many budget revisions had been made over the previous 6 months, none had been required that would have exceeded the limits of delegation proposed by the PEB.

Discussion

The PEB concluded that the provisions of Decision 3/10 were appropriate and should be continued (**Decision 4/5**).

f) Proposed follow-up actions on South-South cooperation between Brazil and Myanmar Mr. Tim Boyle presented the results of follow-up actions on possible S-S cooperation with Brazil. The key issues are:

- The complexities of bilateral cooperation (especially lengthy approval process) were noted:
- A trilateral arrangement involving UN agencies was recommended;
- 3rd-party financing (donor support) is likely to be needed to move forward

Consequently, it was proposed that the PMU continue to explore the possibility of cooperation with Brazil, but that in the absence of 3rd-party funding, it was unlikely that such cooperation was feasible.

Discussion

The PEB concurred with the proposed course of action (Decision 4/12).

Session 2: Items for information

a) Report on Myanmar side-event at COP-23

Daw Khin Hnin Myint summarized the results of the COP-23 side event.

Discussion

U Hla Maung Thein, who represented Myanmar on a panel discussion at the event, commented that he had been interested in the presentations by PNG, and considered that there was some interesting potential for cooperation with PNG. Naw Ei Ei Min commented that in looking at such cooperation, the subject matter should not be limited to government-to-government cooperation, but also embrace opportunities for CSO cooperation, since CSOs also have similar activity of learning and sharing from the region and international level engagement in REDD+ and Climate change initiatives. The possibility of cooperation with PNG was incorporated into **Decision 4/12**.

b) Proposal for expanded information exchange at PEB-5

Mr. Tim Boyle presented a concept for a "REDD+ Retreat", possibly in association with the next meeting of the PEB or a meeting of the Taskforce. The objectives of the Retreat would be to:

- Update all partners on the status of all elements of the Warsaw Framework for REDD+ (NRS, FREL, NFMS, SIS);
- Exchange information on objectives and progress of all REDD+ related initiatives;
- Discuss and agree on approaches to ensure effective coordination among initiatives and the way forward for Myanmar to qualify for REDD+ results-based payments.

Participants would include members of the PEB and Taskforce, staff of the PMU, FAO and UNDP Country Offices, and FAO, UNDP and UNEP Regional Offices, representatives of approximately 12 REDD+ related initiatives, and members of TWGs, giving a total of around 75.

Discussion

The PEB concluded that the concept was a good one. It was proposed that Bago Yoma might be a suitable location. Proposals for additional participants included CSO's, parliamentarians, representatives of donors, and technical experts from other countries. A date in May or June was considered optimal. PEB requested to PMU to give an estimate of the budget for the REDD+ Retreat. The discussion lead to **Decision 4/6**.

Session 3: Items requiring Decisions Work plan for 2018

Daw Khin Hnin Myint presented the budget plan for 2018. Reflecting an acceleration of activities, the proposed budget for FAO is USD 1,052,196; for UNDP USD 1,145,500; and for UNEP (including funds channeled through UNDP), USD 54,348.

Discussion

The PEB noted that there was not yet a workplan presented and instructed the PMU to prepare one (**Decision 4/1**) – it is appended as Annex 1 to this document. The PMU drew attention to the need for an MTR, and instructed the PMU to prepare ToR, to be presented to the next meeting of the PEB, for an MTR scheduled in the 4th quarter of 2018 (**Decision 4/9**). The large amount of funds under Outcome 4 being used for capacity building was noted, and the PEB instructed the PMU to prepare a note clarifying how national capacity is being built through the programme, as required by DACU (**Decision 4/10**). The PEB also noted that the Second National Communication (SNC) is now preparing by the focal agency of ECD and as it is strongly linked to the UN-REDD Programme, PEB instructed the PMU to facilitate the exchange of information relevant to the preparation of a GHG Inventory as a part of SNC development, in order to avoid duplication/contradiction (**Decision 4/11**). The REDD+ MRV Team Leader, Mr. Franz Arnold and Ms. Khin Hnin Myint are already appointed as members of Forestry Sector in SNC development. Finally, the PEB instructed the PMU to ensure more rapid progress on safeguards (**Decision 4/7**).

Decisions and Action points

- Decision 4/1: The PEB provisionally approves the AWP/2018, subject to a revised version showing the timeframe of each activity being circulated for comment.
- Decision 4/2: The PEB approves the M&E plan.
- Decision 4/3: The PEB approves the proposed changes to the Results Framework, subject to modification to the wording of output 5.1
- Decision 4/4: The PEB approves the two requests received from the National REDD+ Taskforce for UN-REDD assistance on issues of relevance to the operations of the Taskforce
- Decision 4/5: The PEB confirms the arrangements related to delegation of authority for budget modifications within the limits established by PEB Decision 3/10
- Decision 4/6: The PEB endorses the proposal to organize a REDD+ Retreat and instructs the PMU to explore the possibility of engagement by other countries
- Decision 4/7: The PEB instructs the PMU to accelerate work on safeguards while stressing the importance of developing a robust approach to safeguards
- Decision 4/8: The PEB instructs the PMU to emphasize awareness raising in 2018, to address the failure to meet targets established in the M&E plan, and to develop plans to

raise awareness of parliamentarians (possibly in conjunction with UNDP's work on this issue) and staff of law enforcement agencies

Decision 4/9: The PEB instructs the PMU to prepare for a MTR, to be held in the 2nd half of the year, and to present to the next meeting of the PEB draft ToR that have been consulted with FD and ECD

Decision 4/10: The PEB instructs the PMU to prepare a note clarifying how national capacity is being built through the programme, as required by DACU

Decision 4/11: The PEB instructs the PMU to facilitate the exchange of information relevant to the preparation of a GHG Inventory with the team preparing the Second National Communication, in order to avoid duplication/contradiction

Decision 4/12: The PEB instructs the PMU to continue to explore opportunities for S-S cooperation with Brazil, and to follow up on the COP-23 side-event by exploring opportunities for S-S cooperation with PNG

Decision 4/13: The PEB instructs the PMU to assist the National REDD+ Taskforce in preparations for the National REDD+ Strategy to be presented to the National Land Use Council

Next meeting

The next PEB meeting will be scheduled for July 2018, with the preferred venue in Yangon.
