It is well informed and designed, based on the inception phase which included inception workshop and situation analyses, to support State institutions and OPDs to advance CRPD implementation of the preconditions of equality and non-discrimination, service delivery, CRPD compliant budgeting, and accountability. The program will ensure meaningful participation of persons with different types of disabilities, both women and men, and of children with disabilities and parents in all activities, at all stages.

Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment

The project will improve capacities of the both national institutions and CSOs to reform procedures and advocate for gender-responsive changes in the legislative and policy framework that would support the prevention of institutionalization and enable transition of persons from institutional living to living independently and in the family and/or community. Also, it will support the Government to develop, adopt and implement guidelines on disability inclusive and gender-responsive budgeting, as well as ensure the independent monitoring for CRPD implementation, including representatives of OPDs and persons with disabilities from underrepresented groups, encouraging the participation of women and girls. Through gender-responsive monitoring the project will ensure improved understanding of specific needs and challenges of men and women, that will enable development of tailor-made activities and services. In addition, the improved evidence base will further contribute to enhanced advocacy initiatives aiming at the improvement of the position of women with disability in Montenegro.
