AMENDMENT OF THE PROJECT DOCUMENT IN RELATION TO THE ACTIVITY OF THE PROJECT AND NEW CONTRIBUTION FROM THE MINISTRY OF CULTURE OF MONTENEGRO

UNDP project number 79633

Title: Beautiful Cetinje

Project purpose: Project Beautiful Cetinje aims to start economic revitalization of the Old Royal Capital through urban reconstruction of the cultural heritage with energy efficiency considerations, provision of vocational trainings, support to small businesses and encouraging green design ideas and innovations in overall urban development.

Fourth amendment proposed in this document covers the following points:

- The amendment of the project is performed in view of new project activity, related to the restoration of the building of the old Ivan Crnojevic's Mill in Cetinje, as one of the Cetinje's cultural properties.
- In this view, Project Document shall be amended as follows: General remarks:
 - The term "monuments of culture" shall be replaced with "cultural property" -page 3,4,5,10

- Expected Outcome 2 - wording "reconstruction of building that are part of cultural heritage" shall be replaced with "restoration of building that are part of cultural heritage" – page 1, page 3 (urban reconstruction of the cultural heritage), 9, 16 (two times), 17.

Page 3 – "over 30 immovable monument of culture" shall be replaced with "many immovable cultural properties"

Page 4 – Section 1.1 Cetinje historical core status

- "the monument of culture of the First category" shall be replaced with "cultural property".

- "In accordance with the Law on Cultural Heritage Protection, in the territory of the town of Cetinje there is the total of 30 protected unmovable monuments of culture (including the Mausoleum to Petar II Petrović Njegoš), 25 of which is located within the monumental ensemble of Cetinje Historical Core, classified in three categories." shall be replaced with "In accordance with the Cultural Property Act, in the territory of the town of Cetinje there is the total of 116 protected unmovable cultural properties (including the cultural properties with memorial characters), 43 of which are located within the urban whole Historic Core of Cetinje, classified as properties of national significance."

- "Today, currently valid Law for conservation of cultural monuments from 1991 regulates work of the service. "shall be replaced with "Today, Cultural Property Act from 2010. regulates work of the service. "

- "The Law about Conservation of cultural monuments from 1991, states that a municipality has obligation to "take a good care of monuments on its territory, to maintain, use and protect them from destructive influences of nature and human acting, to make them available to the public and to provide funding for their regular maintenance". During the development of urban plans, for the purpose of preservation of urban, historical or ambient character of old towns and settlements, municipality is obliged to provide a professional opinion of the Republic Institute for Conservation of Cultural Monuments. The Law states that it is necessary to provide license for any construction works on a monument, which can cause its changes. The licence can be issued by the Republic Institute" or the Regional Institute. (Article 83; par. 5; Law for Conservation of Cultural Monuments of Republic of Montenegro)" shall be replaced with: "The Cultural Proerty Act (Official Gazette of Montegro, no. 49/10) proscribes that Montenegro is obligated to provide protection and preservation of all cultural property which are located on its territory, including internal waters and territorial sea, as well as to take care of protection and preservation of property which are located abroad, if they are important for its history or culture. On the other hand, owners and holders of cultural property, including religious communities, are obligated to protect, respect, maintain and properly use the cultural property they own. Protection of cultural property in planning documents is established trough the production of Study of protection of cultural property and Management plans, while individuals and legal entities have to obtain conservation license from the Ministry of Culture in order to implement the measures on cultural properties. Owner, which is the holder of a cultural property is obligated to appoint a person to conduct expert supervision of implementation of works on a cultural property."

Results and Resources Framework – page 17)

- Total project budget will stay unchanged (US\$ 10,000,000)
- New project activity shall be introduced through RRF, to include all future activities related to 'Cultural heritage restoration and valorization'
- RRF and Annual work plan will be changed/updated in line with new activity (changed documents attached).
- The narrative and financial reporting shall be performed in line with the terms and conditions set out in the CSA between Ministry of Culture and United Nations Development Programme.
