QUESTION 1: How Does the Project Integrate the Overarching Principles in order to Strengthen Social and Environmental Sustainability?

Briefly describe in the space below how the Project mainstreams the human-rights based approach

Project focuses on three critical and complementary aspects of a democratic process. These are election management, political party development, and women's political participation which will enhance electoral processes in Malawi, and ensure credible tripartite election in 2019. The project framework ensures that Malawians rights of assembly/association, freedom of expression, representation, and overall political participation are upheld.

The project mainstreams human rights issues by providing space for participation without any form of discrimination and also building capacities of individuals and national institutions to effectively take part in setting up credible electoral processes that are acceptable by key electoral players.

Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment

The project improves gender equality and women empowerment by ensuring that the Malawi Electoral Commission (MEC) develops and implements gender responsive administrative arrangements and operating procedures to promote inclusivity. MEC will be able to enhance gender equality through engendering voter education materials, training programmes and operations, from voter registration and candidate nomination, to voting and security.

Answer IV-Part A

Through collaboration with UN Women, the project focuses on the voters' attitudes towards women candidates, offers support to women as voters or aspiring candidates, and election administrators. This is envisaged to form a basis of increasing the number of women into elected position as Malawians will be informed on the merits of voting for women (and female youth) and closing the gender equality gap.

Further, the project will enhance the capacity of women and the youth through the working with Centre for Multiparty Democracy by ensuring that women and youth wings (groups) in political parties are meaningfully represented and are able to be streamlined into political party's decision-making processes. This will in turn increase the number of women and youth vying for political positions ahead of the 2019 elections.

Briefly describe in the space below how the Project mainstreams environmental sustainability




The project is expected to have very low environmental impacts. Accordingly, it has not been necessary to undertake an environmental and social impact assessment. The envisaged environmental impact will be storage and disposal of electoral materials both printed and ICT based. The project will ensure that all electoral materials are properly stored in secure warehouses following applicable security, health and safety standards. Additionally, the Malawi Electoral Commission will ensure that paper based materials such as ballot papers are recycled to ensure a minimal impact on the environment if improperly disposed.
