**AMENDMENT TO THE  
COST-SHARING AGREEMENT BETWEEN THE UNITED NATIONS  
DEVELOPMENT PROGRAMME AND THE GOVERNMENT OF NAMIBIA  
REPRESENTED BY THE MINISTRY OF HEALTH AND SOCIAL SERVICES**

**between**

United Nations Development Programme (hereinafter referred to as "UNDP")  
**and**

the Government of Namibia represented by the Ministry of Health and Social Services  
(hereinafter referred to as the "MOHSS")

WHEREAS the Government has informed UNDP of its willingness to amend the Cost-Sharing Agreement (hereinafter referred as CSA) dated 6 April 2017 described in the Project document as Support to MOHSS for accelerated implementation of GFATM under the TB GRANT, Atlas project no. 00046250, in Namibia, and submitted to the Government for information.

WHEREAS the Government and UNDP now wish to amend the Contract as follows:

NOW THEREFORE, UNDP and the Government hereby agree to amend as follows:

1. The MOHSS shall, in the manner referred to in paragraph 2 of this Article, place at the disposal of UNDP an additional contribution of two hundred twelve thousand four hundred forty-three and sixty-nine Namibian Dollars (212,443.69 NAM) to the original CSA signed the 6 April 2017.

3. The MOHSS PMU will transfer funds totaling two hundred twelve thousand four hundred forty-three and sixty-nine Namibian Dollars (212,443.69 NAM) from the TB Grant to UNDP. The MOHSS will inform UNDP when the Contribution is paid via an e-mail, providing the following information: Government's name, UNDP country office, Project no 0046250 and Project title Support to MOHSS for accelerated implementation of GFATM. This information should also be included in the bank advice when funds are transferred to UNDP. As the payment is being made in a currency other than United States dollars, that value of the referenced payment shall be determined by applying the United Nations operational rate of exchange in effect on the date of payment. Should there be a change in the United Nations operational rate of exchange prior to the full utilization by the UNDP of the payment, the value of the balance of funds still held at that time will be adjusted accordingly. If, in such a case, a loss in the value of the balance of funds is recorded, UNDP shall inform the Donor with a view to determining whether any further financing could be provided by the Donor. Should such further financing not be available, the assistance to be provided to the project may be reduced, suspended or terminated by UNDP

4. The above schedule of payments takes into account the requirement that contributions shall be paid in advance of the implementation of planned activities. It may be amended to be consistent with the progress of project delivery.

5. All financial reports will be integrated with the original CSA signed the 6 of April 2017 and statements shall be expressed in United States dollars.


This Agreement shall enter into force upon the signature of this Agreement by parties hereto, on the date of the last signature.
