Monitoring of RFF funded projects will be conducted using the COVID-19 Monitoring Dashboard, which draws live data from the COVID-19 Marker and Atlas. Reporting will be streamlined into the COVID-19 reporting exercise using the mini-ROAR and COVID-19 indicators. Delivery updates may be requested through your Regional Bureaus, on a quarterly basis.

Kindly note that the implementation of this allocation must strictly adhere to the established corporate policies and procedures as prescribed in the POPP. The UNDP Resident Representative in Namibia is responsible for the effective and prudent use of the funds allocated to your office for the intended purposes. The planned project activities as presented in the proposal must start within six weeks (as shown in Atlas expenditure) and be completed within 18 months after the date of this allocation letter.
